The Leader advised that the date of the next Council meeting had been changed from 29th April to Thursday 23rd April so the Council could consider its response to the Welsh Government White Paper Reforming Local Government: Power to Local People, by the deadline of 28th April. The group leaders had already met for an initial discussion. He also advised that the date of the joint seminar with Powys teaching Health Board had been moved to 29th April. The leader repeated the announcement made at Cabinet that a working group was being established by the portfolio holder for the Welsh language to look at what steps the Council could take to arrest the decline in the use of Welsh in the county.

The Chief Executive congratulated Catering staff from Powys County Council who had enjoyed considerable success at the Lead Association for Catering in Education's (LACA) Welsh Region Recognition of Excellence Awards. Jane Vaughan of Llanidloes High School won gold in the Celtic Creations Display Salon Final's Decorated Novelty Cake category with Velma Hutchison from Builth High School being awarded silver in the same category. Archdeacon Griffiths Church in Wales School beat all other primary schools in Wales to be crowned Welsh Primary School Catering Team of the Year. Gwernyfed and Crickhowell high schools finished runners-up in the Welsh Secondary School Catering Team of the Year and Newtown High School's Melissa Cooke was named Welsh Secondary School Catering Frontline Employee of the Year. Finally, Welsh Catering Management Team of the Year was awarded to Powys County Council.

In response to a member's question, the Chief Executive expressed his confidence in the County Hall restaurant gaining an improved food hygiene rating under the leadership of the Catering Manager.

<b>8.</b>	<b>COUNCIL TAX RESOLUTION</b>	<b>CC31 – 2015</b>

The Portfolio Holder for Finance reminded Council that the Council Tax resolution was based on a proposed Council Tax increase of 4% as agreed at the Council meeting on 11<sup>th</sup> February 2015.

The Conservative group indicated that they would not be supporting the increase because they felt that money was being wasted by the Council. They questioned the amount spent on the voluntary severance scheme and the numbers of staff subsequently re-employed, the amount spent on sub-contractors and the cost of leasing a building at the Royal Welsh Show Ground. In response to a question about the costs of the lease car scheme, the Strategic Director Resources explained that projected savings would be achieved from 1<sup>st</sup> June 2014 and that the total savings over 3 years would be £117,000. The Leader said that he would look at any specific examples of waste raised by the Conservative group but reminded Members that Council had already agreed the budget and that the purpose of the meeting was to set the Council Tax.

At a meeting of the Cabinet on the 11th November 2014, the Council calculated the following amounts for the year 2015/2016 in accordance with Regulations made under Section 33 (5) of the Local Government Finance Act, 1992.

## 2. THE CALCULATION

2.1. THAT the following amounts be now calculated by the Council for the year 2015/2016 in accordance with Sections 32 to 36 of the Local Government Finance Act, 1992:

- (a) £416,596,492.91      being the aggregate of the amounts which the Council estimates for the items set out in Section 32 (2) (a) to (e) of the Act
- (b) £176,229,994.50      being the aggregate of the amounts which the Council estimates for the items set out in Section 32 (3) (a) to (c) of the Act
- (c) £240,366,498.41      being the amount by which the aggregate at 2.1(a) above exceeds the aggregate at 2.1(b) above, calculated by the Council, in accordance with Section 32 (4) of the Act, as its budget requirement for the year
- (d) £174,188,316.00      being the aggregate of the sums which the Council estimates will be payable for the year into its General Fund in respect of re-distributed Non Domestic Rates, Revenue Support Grant, special grant or additional grant
- (e) £1,086.86              being the amount at 2.1(c) above less the amount at 2.1(d) above, all divided by the amount at 1.3(a) above, calculated by the Council, in accordance with Section 33 (1) of the Act, as the basic amount of its Council Tax for the year
- (f) £2,511,347.41      being the aggregate amount of all special items referred to in Section 34 (1) of the Act
- (g) £1,045.62              being the amount at 2.1(e) above less the result given by dividing the amount at 2.1(f) above by the amount at 1.3(a) above, calculated by the Council, in accordance with Section 34 (2) of the Act, as the basic amount of its Council Tax for the year for dwellings in those parts of its area to which no special item relates.

**12.1 Question to the Portfolio Holder for Regeneration and Planning from County Councillor Gary Price**

**Following the announcement that the Tour of Britain won't feature in Powys in 2015 can the Portfolio Holder tell Council what discussions have taken place pre and post the announcement?**

*In 2013 all local authorities in Wales were invited to express interest in involvement in The Tour of Britain Cycle Race. A letter was sent by Powys County Council expressing such an interest, following on from hosting successful stage starts from 2010 onwards.*

*At the end of 2013 a five year strategic plan was put together by the Welsh Government's Major Events Unit, in conjunction with Sweetspot, Tour of Britain organisers, outlining which areas in Wales would be involved in The Tour between 2014 and 2018.*

*This plan included a stage start for Powys in 2014. From the outset it was always in the plan that there would only be one stage in Wales in 2015 and this would be in North Wales, with The Tour having a more northern focus in general, and was not anything that Powys County Council could influence.*

In response to Councillor Price's supplementary question, the Portfolio Holder agreed that the Council's response to the news that "Powys shouldn't be greedy" wasn't a good choice of words and she confirmed that the Council would continue to work to bring prestigious events to the county.

## **12.2 Question to the Portfolio Holder for HR and ICT from County Councillor Aled Davies**

**Members of the public have raised concerns about smoking on Powys County Council property. There are clear rules on smoking on Council property. What actions can be taken to ensure that the Council's policy is complied with?**

*The Council introduced a Smoke Free Workplace Policy in August 2008. This policy was revised in August 2013. The policy applies to all employees, elected members, visitors, contractors, service users and other members of the public whilst on/in Council premises.*

*The policy states that Smoking will not be permitted in or on any of the Council's premises or in vehicles owned, occupied or managed by the Council. An e-mail reminding employees of their responsibilities in respect to this policy was sent out on 2<sup>nd</sup> December 2014. The arrangements for the enforcement of the policy are described in the extract below:*

*"It is the responsibility of all employees and line managers to uphold the standards of a healthy workplace and to ensure that the policy is complied with.*

*Elected Members, Directors, Heads of Service and Senior Managers, all have a responsibility to ensure that the policy is applied consistently throughout the Council by taking necessary action whenever they witness, or receive reports of, this policy being contravened.*

*Advice and guidance regarding the practical implementation of this policy and instances of non-compliance should be sought from Human Resources.*

*Failure to adhere to this policy, despite support offered, and to keep Council premises smoke-free, will result in the Council's Disciplinary Procedure being applied.*

*Anyone covered by this policy who is found smoking in or on Council premises as outlined above, should be asked to stop and advised that they are breaching Council policy. Should an employee challenge their manager on their right to smoke, the manager should refer to the following:*

- *This is a Council policy relating to health and safety at work and is based on the same principles as policies relating to dangerous machinery, toxic substances etc.;*
- *The Council wishes to convey positive health messages to its employees and the public;*
- *An employee cannot challenge the employer's right to introduce healthier and safer workplaces.*

*A refusal to stop is unacceptable and should be reported to senior management. It is the responsibility of the employee's service area to take the necessary action, including disciplinary action if required, to discourage smoking in prohibited areas, taking advice from HR as necessary.*

*Contractors breaching the policy should be requested to cease smoking on the premises. A contractor who refuses to stop smoking should be required to leave the premises."*

The Leader indicated that he wanted to look into the matter with the Trade Unions. There was no supplementary question.

### **12.3 Question to the Portfolio Holder for Highways from County Councillor Dawn Bailey**

**The new National Transport Plan 2015 will set out in detail how the Welsh Government proposes to deliver in those areas of transport for which it is responsible in order to achieve the outcomes as set out in the Wales Transport Strategy from 2015 and beyond.**

**The consultation period on the draft National Transport Plan 2015 ends on 11<sup>th</sup> March 2015.**

**As Local Member for the border constituency of Trewern located on the borders of Shropshire and Montgomeryshire, it is extremely frustrating to see the Newtown bypass proposals progress whilst a scheme that was originally identified some forty years ago and more recently in 2004 for similar interventions on the A458 Buttington Cross to Wollaston Cross trunk road still remain identified in the Plan as being subject to further consideration.**

**It has been announced recently the Transport Minister, Edwina Hart AM has established a Cross Border Road Forum in order to help unlock the**

current impasse on road schemes that cross the English and Welsh borders. Specific mention has been made to the Forum re-opening discussions on the A483 Llanymynech to Pant bypass scheme located on the main trunk route between Wrexham and Swansea. Could the Portfolio Holder therefore confirm what representation this Council has on the Forum and whether the A458 Buttington Cross to Wollaston Cross trunk road scheme is also to form part of future discussions?

Furthermore, what assurance can the Portfolio Holder give me this Council remains committed to improving the east-west corridor transport links between England and Wales?

*Firstly, I would wish to take the opportunity to thank Cllr. Bailey for her continued lobbying of the Minister over many years which has supported localised improvements to sections of the Trunk Road.*

*Secondly, to note that the Welsh Government's investment in Mid Wales' infrastructure is appreciated and to say that the County Council is fully supportive of the Minister's announcements regarding the removal of critical restrictions on the East-West road network, as at Newtown and Pont ar Dyfi.*

*Reaching a consensus on investment priorities that cross administrative borders can be difficult but it does appear that steps are being taken to overcome this. At present the Council has not been informed that any "Forum" has been set up. What is clear is that, following consultation with the Secretary of State for Transport, Welsh Government officials and their counterparts from the Highways Agency will be meeting to discuss common highway links. This should include the A483 Llanymynech to Pant bypass and the A458 Buttington Cross to Wollaston Cross section which are not currently included in the Agency's Major Projects Programme.*

*However, I do understand local concerns raised by current consultation on a Draft revision of the National Transport Plan. As it stands, there are a number of road schemes within Powys which remain in the "to do" category and those identified only for "further consideration" include the Builth and Rhayader bypasses and the A458 Buttington Cross to Wollaston Cross improvement.*

*A response to the consultation is being drawn up on a regional basis in order to set out the combined priorities and concerns of local authorities in mid-Wales (i.e. Powys, Ceredigion CC and Gwynedd Councils). It is proposed to include the following text as part of that response:*

*"With regard to mid Wales the NTP does not capture the need for improvements to the following stretches of highway which have been identified as being problematic in terms of safety, and which were identified as carrying significant heavy and light freight traffic in 2012 cordon counts:*



- *A458 from Buttington Cross to the border at Middletown and on to Halfway House in Shropshire (HGVs and LGVs 26% of all traffic)”*

*The scheme has also been referenced in the recently published Mid Wales Joint Local Transport Plan and in the region’s earlier Highways Strategy; Additionally, as the WLGA is in the process of updating its “Manifesto for Rural Wales” it has been put to them that this scheme, and Llanymynech-Pant, should be brought forward so as to be ‘ready to start’ when funding becomes available.*

*As we know, the border is invisible to both businesses and the region’s economy. What is needed now is a collaboration that supports public safety, improves accessibility and beneficial development and the Council will continue to press for investment in this part of the national road network.*

Councillor Bailey did not have a supplementary question but thanked the Portfolio Holder for his support.

#### **12.4 Question to the Leader from County Councillor Gwilym Williams**

**Many people in my constituency and myself are concerned about the number of consultants that are employed by Powys Council.**

**There has recently been an article in the paper where three consultants obtained over £1 million in a few years salaries.**

**Therefore, you are responsible for all the portfolio holders as leader, and consultants are employed across all of Powys in different portfolio departments.**

**My question would be to you as leader, can you tell me how many consultants are currently employed by Powys County Council, and how much money do we pay as an authority pay these consultants per month?**

*Details of the consultants employed by the Council in 2014/15 are filed with the signed minutes.*

*The Council has historically commissioned consultancy services to deliver specialist advice and services when these specialist skillsets were not available from within the Council. With ever decreasing funding from Welsh Government, there is significant pressure on the Council to dramatically and quickly change the way in which it delivers and / or works with others to deliver services. This pressure, coupled with the fact that the Council has and will need to continue to reduce the number of staff that it directly employs, means that the Council’s capability for designing and delivering major transformational change projects without externally sourced advice and*

*support is limited and the need to commission specialist consultancy services over the next few years is likely to increase. Without this specialist support, projects such as those associated with school and social care improvement are unlikely to be delivered in a timely and cost effective fashion. It is however acknowledged that the Council needs to continue to be very clear about the specification for commissioned consultancy work to ensure that such contracts deliver upon expectations both in terms of quality and timeliness but also offer value for money.*

In answer to Councillor Williams' supplementary question, the Leader explained that the figures related to March 2014 to February 2015 and he agreed to provide Members with details and the costs of agency staff employed by the Council. He also advised that he had asked for a report to be prepared for Cabinet requiring Portfolio Holder approval for the appointment of any consultants costing in excess of £10,000.

**12.5 Question to the Portfolio Holder for Highways from County Councillor Russell George**

**Will the Cabinet member provide an update on rubbish clearance from roadsides and hedges throughout Powys?**

*It is our current practice to routinely undertake litter picking throughout Trunk and Primary County road network twice per year. The first litter pick is undertaken during March prior to the grass growing, with the second being undertaken around September time. To put some perspective this costs in the order of £40k per occasion entailing walking the majority of the 500 miles or so of road both sides. In addition to this routine maintenance, endeavours are made to respond to reports and complaints to deal with specific 'hot-spots' of littering.*

*It is disappointing that this level of expenditure has to be directed to deal with what is essentially a totally unnecessary problem. On the other hand, it is encouraging to note a real increase lately in the number of volunteer groups; including some led by fellow County Councillors, taking the initiative and helping out with this activity and making a visible improvement in their community.*

There was no supplementary question.

**12.6 Question to the Portfolio Holder for Highways from County Councillor Russell George**

**Will the cabinet member provide an update on the state of Roads in Powys that are the responsibility of Powys County Council?**

*The scope of the question is quite general, so my response will be in a similar vein but if a more specific issue is raised, I will gladly respond accordingly.*

*The quick answer to the question is that our county road network is in a state of deterioration, but that it continues to be maintained safely.*

*Given the current minimal level of budget which we are able to allocate towards the maintenance of our county road network, the emphasis of effort is directed at attending promptly to safety issues and undertaking as much of the fundamental basic maintenance as possible.*

*Over the last 3 years we have had the benefit of the LGBI (Local Government Borrowing Initiative) scheme which has amounted to an investment of over £15M primarily targeted at bringing some of our non-principal county roads back into repair. This has made some improvement to the overall condition of the county roads, but to put this into perspective, the current balance of identified county road structural repair schemes still stands at approximately £30M, with the current annual maintenance budget roughly at one third of that required to maintain the roads in a 'steady state' (neither improving nor deteriorating).*

*Without the added capital investment brought by the grant scheme which finishes this year, the challenge to maintain our network over the coming years will be a drastically increasing one, and new methods and innovation will be necessary if we are to allay the potential of an accelerating decline of the state of our road network.*

Councillor George asked as his supplementary question whether the Council had made representations to the Welsh Government about the Local Government Borrowing Initiative coming to an end. The Portfolio Holder advised that he was not aware of what representations had been made. He did note that the money had enabled the Council to undertake more works and that currently the Council rated the lowest amongst all Welsh authorities for roads condition and had the lowest spend per kilometre. He also noted a further threat to the Highways budget by the Trunk Road Agency having had its budget cut by Welsh Government.

**12.7 Question to the Portfolio Holder for Adult Social Care from County Councillor Russell George**

**Will the Cabinet Member please provide an update on what lessons have been learnt following the Independent review on domiciliary care?**

**Has the Authority contacted service users or family members to apologise for the failings of the Authority in regards to domiciliary care?**

*We recognise that there are lessons to be learnt in what has been one of the largest transformational changes the council has undertaken. The Institute of Public Care's report and PCC's response are essential parts of our learning process as we strive to make improvements through different service delivery models. The report and the initial response to the recommendations were*

accepted and agreed by the Cabinet of Powys County council on 06/01/15 ([Powys County Council Intranet: Committee Meeting Documents](#)). There was also a further apology given by myself and the Strategic Director of People on the 06/01/15 for the distress and anxiety that the difficulties had caused our service users.

The review was instigated following feedback from service users directly affected by changes; the experience for some service users, particularly in the north of the county, had been very difficult and unacceptable and we deeply regret that this was the case. This was communicated to individuals and families throughout the safeguarding and complaints process and in communicating the outcome of individual safeguarding investigations to the individual service users and families impacted.

A second more detailed report responding to the Independent Review of the Commissioning of Domiciliary Care is included on the Cabinet agenda for 3<sup>rd</sup> March 2015 ([Powys County Council Intranet: Committee Meeting Documents](#)). This report includes an accountability framework and a detailed action plan to progress learning and improvement. This report and the appendix will I trust provide in detail a response to the Member's question (detailed above). This report and the detailed action plan combined with the position outlined to the cabinet report of 06/01/15 demonstrates that considerable work is already underway and future work to be undertaken.

In response to the review and as outlined in the completed strategic accountability framework and action plan; Adult Social Care have established a dedicated project group and project plan to progress the strategic review of the model of domiciliary care. The strategic review includes the Council's intended delivery mechanism for the following:

- Sustainable, safe and affordable delivery of domiciliary care in one of the UK's most sparsely populated areas with our providers
- Real-time reporting through the electronic rollout of any missed or late calls
- Quality monitoring of safe delivery
- Effective communication and engagement with our service users about future options, especially when any change of provider or carer may be necessary at short notice
- Recruitment and retention to a care workforce in an area of low unemployment where caring work is not viewed as an attractive option
- Understanding the impact of full unit costs including the complexity of travel time and delivery in isolated communities and what this means for future sustainability of the domiciliary care market in partnership with the providers
- Sharing learning and experiencing across the network both with Local authorities and providers ,the market is relatively inexperienced in progressing through these times of severe and increasing austerity and Powys is not alone with these challenges

- *Building greater community networks through the third sector and community*
- *Approaches and fully understanding where our demand is coming from- “ a whole system approach “ – this includes our social work practice, development of telehealth and telecare, short term care and reablement, working with our partners especially the NHS, GP’s and PtHB.*

There was no supplementary question.

**Mae cyfnod ymgynghori drafft y Cynllun Trafnidiaeth Cenedlaethol 2015 yn dod i ben ar 11 Mawrth 2015.**

**Fel Aelod Lleol etholaeth y gororau, Trewern, a leolir ar y ffin rhwng Swydd Amwythig a Sir Faesyfed, y mae'n rhwystredig iawn gweld datblygiadau o ran ceisiadau ffordd osgoi'r Drenewydd tra bo cynllun a ddynodwyd yn wreiddiol ryw ddeugain mlynedd yn ôl ac yn fwy diweddar yn 2004 ar gyfer ymyraethau tebyg ar yr A458, cefnffordd Buttington Cross i Wollaston Cross yn parhau wedi ei ddynodi yn y Cynllun fel testun ystyriaeth bellach.**

**Cyhoeddwyd yn ddiweddar fod y Gweinidog Trafnidiaeth, Edwina Hart AC wedi sefydlu Fforwm Ffordd Draws Ffiniol er mwyn helpu i ddatgloi'r cyfyngder presennol ar gynlluniau ffordd sy'n croesi ffiniau Cymru a Lloegr. Cafodd cyfeiriad penodol ei wneud i'r Fforwm ailagor trafodaethau ar gynllun ffordd osgoi A483 Llanymynech i'r Pant a leolir ar y brif gefnffordd rhwng Wrecsam ac Abertawe. A all deiliad y portffolio, felly, gadarnhau pa gynrychiolaeth sydd gan y Cyngor hwn ar y Fforwm ac a yw'r cynllun cefnffordd A458 Tal-y-Bont (Buttington Cross) i Wollaston Cross hefyd i ffurfio rhan o'r trafodaethau yn y dyfodol?**

**Ymhellach, pa sicrwydd all Ddeiliad y Portffolio ei roi i mi fod y Cyngor hwn yn parhau'n ymroddedig i wella cysylltiadau trafndiaeth coridor y dwyrain-gorllewin rhwng Cymru a Lloegr?**

*Yn gyntaf, hoffwn fanteisio ar y cyfle i ddiolch i'r Cynghorydd Bailey am ei lobïo parhaus i'r Gweinidog dros nifer o flynyddoedd a oedd yn cefnogi gwelliannau lleol i adrannau o'r gefnffordd.*

*Yn ail, nodaf fod buddsoddiad Llywodraeth Cymru yn isadeiledd Canolbarth Cymru yn cael ei werthfawrogi ac mae'r Cyngor Sir yn gwbl gefnogol o ddatganiadau'r Gweinidog o ran cael gwared ar gyfyngiadau argyfyngus ar rwydwaith y ffordd Dwyrain-Gorllewin, fel yn y Drenewydd a Phont ar Ddyfi.*

*Gall dod i gytundeb ynghylch blaenoriaethau buddsoddi sy'n pontio ffiniau gweinyddol fod yn anodd, ond ymddengys fod camau ar waith i oresgyn hyn. Ar hyn o bryd nid yw'r Cyngor wedi cael gwybod fod unrhyw "Fforum" wedi ei sefydlu. Yr hyn sy'n glir, yn dilyn ymgynghoriad â'r Ysgrifennydd Gwladol Trafnidiaeth, yw bod swyddogion Llywodraeth Cymru a'u cymheiriaid o'r Asiantaeth Briffyrdd, yn cyfarfod i drafod cysylltiadau priffyrdd cyffredin. Dylai hyn gynnwys ffordd osgoi A483 Llanymynech i'r Pant a'r A458, adran Buttington Cross i Wollaston Cross na chaiff eu cynnwys ar hyn o bryd ym Mhrif Raglen Prosiectau'r Asiantaeth.*

*Fodd bynnag, rydw i'n deall pryderon lleol a godir gan ymgynghoriad cyfredol am adolygiad Drafft y Cynllun Trafnidiaeth Cenedlaethol. Fel y saif, ceir nifer o gynlluniau ffordd ym Mhowys sy'n parhau yn y categori "i'w gwneud" ac mae'r rheini a ddynodwyd yn unig ar gyfer "ystyriaeth bellach" yn cynnwys ffordd osgoi Llanfair-ym-muallt a Rhaeadr a gwelliant i'r A458 Tal-y-Bont (Buttington Cross) i Wollaston Cross.*

*Mae ymateb i'r ymgynghoriad yn cael ei lunio ar sail ranbarthol er mwyn gosod y cyd-flaenoriaethau a phryderon awdurdodau lleol yng Nghanolbarth Cymru (hynny yw Powys, Cyngor Sir Ceredigion a Chynghorau Gwynedd). Cynigir bod y testun canlynol yn cael ei gynnwys fel rhan o'r ymateb hwnnw:*

*"Gyda golwg ar Ganolbarth Cymru nid yw'r NTP yn dal yr angen am welliannau i'r darnau canlynol o briffordd sydd wedi eu dynodi fel rhai problematig o ran diogelwch, ac a ddynodwyd fel rhai sy'n cario traffig trwm sylweddol a thraffig cludiant ysgafn yng nghyfrif Cordon 2012:*

*Cyfeiriwyd at y cynllun hefyd yng Nghydgynllun Trafnidiaeth Lleol Canolbarth Cymru yn ddiweddar ac yn Strategaeth Priffyrdd cynharach y rhanbarth; Yn ychwanegol at hyn, gan fod Cymdeithas Llywodraeth Leol Cymru (CLILC) yn y broses o ddiweddarau ei "Fanifesto ar gyfer Cymru Wledig", awgrymwyd iddynt y dylai'r cynllun hwn, a Llanymynech-Pant, gael ei symud yn ei flaen fel ei fod yn 'barod i ddechrau' pan fydd yr arian ar gael.*

*Fel y gwyddom, mae'r ffin yn anweledig i fusnesau ac i economi'r rhanbarth. Yr hyn sydd ei angen nawr yw cydweithio sy'n cefnogi diogelwch y cyhoedd,*

*yn gwella hygyrchedd a datblygiad buddiol a bydd y Cyngor yn parhau i ymgychu am fuddsoddiad yn y rhan hwn o'r rhwydwaith ffordd genedlaethol.*

Nid oedd cwestiwn atodol gan y Cyngorydd Bailey ond diolchodd i Ddeiliad y Portffolio am ei gefnogaeth.

**Felly, fel arweinydd, chi sy'n gyfrifol am yr holl ddeiliaid portffolio, a chaiff ymgynghorwyr eu cyflogi ledled Powys mewn gwahanol adrannau portffolio.**

**Fy nghwestiwn i i chi fel arweinydd yw, a allwch chi ddweud wrthyf faint o ymgynghorwyr gaiff eu cyflogi'n gyfredol gan Gyngor Sir Powys, a faint ydym ni fel awdurdod yn ei dalu i'r ymgynghorwyr hyn yn fisol?**

*Caiff manylion am yr ymgynghorwyr a gyflogir gan y Cyngor yn 2014/15 eu ffeilio gyda'r cofnodion arwyddedig.*

*Yn hanesyddol y mae'r Cyngor wedi comisiynu gwasanaethau ymgynghori i gyflenwi cyngor a gwasanaethau arbenigol pan na fo'r sgiliau arbenigol hyn wedi bod ar gael oddi fewn i'r Cyngor. Gydag arian yn lleihau fwyfwy o du Llywodraeth Cymru, ceir pwysau sylweddol ar y Cyngor i newid y modd y mae'n cyflenwi a/ neu'n gweithio gydag eraill i gyflenwi gwasanaethau, a hynny'n ddramatig ac yn gyflym. Mae'r pwysau hyn, ynghyd â'r ffaith fod y Cyngor wedi, ac y bydd angen i'r Cyngor barhau i leihau'r nifer o staff y mae'n eu cyflogi'n uniongyrchol, yn golygu fod gallu'r Cyngor i ddylunio a chyflenwi prosiectau newid trawsffurfiol mawr heb gyngor a chymorth o ffynhonnell allanol wedi ei gyfyngu ac y mae'r angen i gomisiynu gwasanaethau ymgynghori arbenigol yn debygol o gynyddu. Heb y gefnogaeth arbenigol hon, mae prosiectau fel y rheini sy'n gysylltiedig â gwella gofal cymdeithasol ac ysgolion yn annhebygol o gael eu cyflenwi mewn modd amserol a chost effeithiol. Fodd bynnag, fe gaiff ei gydnabod fod angen i'r Cyngor barhau i fod yn glir iawn ynghylch y fanyleb ar gyfer gwaith ymgynghorol a gomisiynir i sicrhau fod contractau o'r fath yn cyflawni disgwyliadau o ran ansawdd ac yn amserol, ond hefyd yn cynnig gwerth am arian.*

Yn ychwanegol at y cynnal a chadw rheolaidd hwn, caiff ymdrech ei wneud i ymateb i adroddiadau a chwynion i ddelio â manau penodol o sbwriel sy'n peri poendod.*

*Y mae'n siom fod yn rhaid i'r lefel hwn o wariant gael ei gyfeirio at fynd i'r afael â'r hyn sydd yn broblem gwbl ddianghenraid yn y bon. Ar y llaw arall, y mae'n galonogol nodi gwir gynnydd yn ddiweddar o ran y nifer o grwpiau gwirfoddoli; gan gynnwys rhai a arweinir gan Gynghorwyr Sir, sy'n geffylau blaen o ran helpu â'r gweithgaredd hwn a gwella'u cymunedau mewn ffordd amlwg.*

Mae hyn wedi cyfrannu at wella cyflwr cyffredinol y ffyrdd gwledig, ond o'i roi*



*mewn persbectif, mae cydbwysedd presennol cynlluniau atgyweirio strwythurol dynodedig ffyrdd y sir yn parhau ar tua £30M, gyda'r gyllideb flynyddol gyfredol ar gyfer cynnal a chadw tua thraean o'r hyn sy'n ofynnol i gynnal a chadw'r ffyrdd mewn 'cyflwr sefydlog' (heb eu gwella a heb ddirywio).*

*Heb y buddsoddiad cyfalaf ychwanegol a ddaw yn sgil y cynllun grant sy'n gorffen eleni, bydd yr her i gynnal ein rhwydwaith dros y blynyddoedd sy'n dod yn cynyddu'n sylweddol, a bydd dulliau newydd ac arloesedd yn angenrheidiol os ydym am liniaru posibilrwydd o gyflymu o ran dirywiad ein rhwydwaith ffyrdd.*

Cwestiwn atodol y Cynghorydd George oedd a oedd y Cyngor wedi gwneud sylwadau i Lywodraeth Cymru ynghylch y ffaith fod Menter Benthycia Llywodraeth Leol yn dod i ben. Nododd hefyd fygythiad pellach i gyllideb y Briffordd gan fod cyllideb yr Asiantaeth Cefnffyrdd wedi ei dorri gan Lywodraeth Cymru.
