It is anticipated that implementation of the revised home to school transport policy would have an impact on some Powys residents in the short term, due to the proposal to cease reimbursing learners aged 16 – 19 who travel out of county for post-16 provision and the proposal to change the provision of transport to the nearest school in the 'language of choice'. Transition arrangements will put in place to minimise this impact.
