LICENSING ACT 2003

Licensing Sub-Committees – Procedural Guidelines for the conduct of hearings in accordance with the Licensing Act 2003 (Hearings) Regulations 2005 (“the Regulations”)

Introduction

The four licensing objectives, as set out in the Licensing Act 2003 are:

- **The prevention of crime and disorder**
- **Public safety**
- **The prevention of public nuisance**
- **The protection of children from harm**

Each application that comes before a sub committee of the Authority will be treated on its own merits and this licensing authority will take its decision based upon the merits of the application, taking into account the need to promote the four licensing objectives. This Authority will also have regard to its Statement of Licensing Policy and the guidance issued under section 182 of the Licensing Act 2003.

1. The hearing will normally be held in public. However, the sub committee may exclude the public from all or part of a hearing where it considers that the public interest in so doing outweighs the public interest in the hearing, or that part of the hearing, taking place in public.
2. The hearing shall take the form of a discussion led by the Licensing sub committee and cross examination will not be permitted except at the discretion of the sub committee if it is required to consider the application or representations. This is in accordance with Regulation 23 of the Regulations. A party wishing to cross examine another party must make an application to the sub committee.
3. The procedure at the hearing shall be determined by the sub committee, normally in accordance with the following guidelines.
4. The sub committee shall appoint a Chairman.
5. The Chairman will welcome everyone to the hearing and will introduce him/herself and the other members of the sub committee.
6. The Legal Adviser to the sub committee will ask everyone present to introduce themselves and will explain the procedure to be followed. He/she will ask the applicant, if unaccompanied, if he/she was aware of the right to be represented. The sub committee will also consider any

- request made by a party under Regulation 8(2) for permission for another person to appear at the hearing as a witness.
7. The Licensing Officer will present a report outlining the nature of the application to be considered, any relevant representations and policy statements. The sub committee may ask any relevant questions of the officer through their Legal Adviser.
 8. The applicant (or his/her representative) will be invited to put his/her case. The applicant may call witnesses to support the case provided that the sub committee have given permission to do so. The sub committee and other parties who have made relevant representations may ask any relevant questions of the applicant or of persons representing them. The sub committee should ask questions through their Legal Adviser.
 9. The Chairman will then invite those parties making representations to address the sub committee. The sub committee may ask relevant questions of those parties making representations through their Legal Adviser. The applicant or his/her representative may also ask relevant questions of those parties making representations.
 10. The Chairman will invite the applicant (or his/her representative), and any parties making representations, to briefly summarise their points if they wish.
 11. The sub committee may ask relevant questions of any party during the hearing through their Legal Adviser, but should refrain from any discussion of the merits of the case.
 12. The sub committee will retire with their Legal Adviser to deliberate in private. If it is necessary to recall any party to provide further information or clarification, all parties at the hearing will be asked to return.
 13. When the sub committee has reached its conclusion, the parties will be recalled and the decision will be announced to the applicant by the Legal Adviser to the sub committee, accompanied by, as appropriate, a description of any conditions which are to be attached to the grant of a licence and the licensing objectives that they relate to. Reasons will be given for the decision. That information will also be given to the applicant in writing as soon as is practicable and he/she will be told of any statutory rights of appeal that are available. In cases where a decision cannot be given at the end of a hearing, the applicant and those parties present will be notified of the decision within five working days.

PLEASE NOTE:

- Any person attending the hearing, who, in the opinion of the Chairman, is behaving in a disruptive manner, may be required to leave.
- Late additions to representations and evidence will only be considered with the agreement of all parties present
- The sub committee may allow a maximum period of time for each party to make all relevant statements in support of their written representations. The sub committee would request that all parties avoid repetition and keep the discussion moving in the interests of efficiency.
- Decisions will generally be taken regardless of whether the applicant or those who have made written representations are present. All notices and written representations received from absent parties will be considered. However if a party is unable to attend a hearing due to unforeseen circumstances and would wish to be present, that party should contact the relevant Licensing Officer or Committee Clerk by telephone in order to explain the circumstances. In such a case, the sub committee may be prepared to adjourn the hearing.

SUBJECT: Application for a New Premises Licence – The Old School, New Radnor

REPORT FOR: **DECISION**

1. APPLICATION

- 1.1 On 3rd December 2018, an application was received from Ruth Watson of Tregwynt, Mutton Dingle, New Radnor, Presteigne for a new premises licence for The Old School, School Lane, New Radnor, Presteigne, Powys, LD8 2SS.
- 1.2 A location map of the premises is set out at **Annex A**, and a copy of the application and a plan of the premises are reproduced at **Annex B**.
- 1.3 The Proposed Premises is an old school being used as a community amenity. It is run by a committee for ad hoc licensable events. The applicant has already run a number of licensable events from the premises authorised by Temporary Event Notices:
- 20/12/18 – 26/12/18 sale for alcohol daily between 11.00 hours and 23.00 hours for village social events
 - 30/12/18 – 05/01/19 sale of alcohol daily between 12.00 hours to 01.00 hours for village social events
- The licensing authority has not been made aware of any complaints in relation to these events.
- 1.4 The applicant & The Licensing Authority satisfied procedural obligations by consulting the Responsible Authorities and advertising the application.
- 1.5 The Applicant has applied for a Premises Licence authorising

**Sale of Alcohol 12.00 to 23.00 hours daily, New Year's Eve until 01.00hours
Entertainment including:
Live Music 15.00 to 23.00 hours daily
Recorded Music 10.00 to 23.00 hours daily
Showing of films 15.00 to 23.00 hours daily**

However Live Music and Recorded Music would not be licensable between these hours for Alcohol Licensed Premises following the deregulation of Live and Recorded Music

1.6 The conditions arising out of the operating schedule and offered by the applicant would be:

- A member of the organising committee will be present for the duration of any event authorised by this licence.
- The premises shall have a security alarm that is operational
- When the premises is not being used for events involving the sale or consumption of alcohol any stock of alcohol shall be secured in a locked cupboard
- There will be no sale of alcohol during school hours
- An age restricted sales policy, Challenge 21 will in operation and includes a refusals book.

2. REPRESENTATIONS

2.1 Responsible Authorities

- Police have responded with no objections
- Fire Authority have responded with no objections
- Trading Standards have responded with no objections
- Health and Safety have responded requesting conditions that have been agreed with by the applicant (**Annex C**)

2.2 Other Persons

Objections

Representations were received from a local resident raising concerns about

- Concerns about potential for drink driving of people attending events there
- Protection of children from harm given the close proximity to the Play Park and vehicle movements given the lack of parking outside the premises

A copy of the objection letter is produced at **Annex D**

2.3 Enquiries made with Dyfed Powys police of any offences of drink driving in the vicinity of this premises during the dates of the events above reveal that there were no arrests made for drink driving during this period that relate to The Old School, New Radnor. There was a call made by a resident on 4th Jan 2019 reporting that they believed two local residents whose vehicles were parked at The Old School House could possibly drive home later in the night. Officers did attend but neither of these vehicles moved all night

3. OPTIONS

3.1 In determining the application for the Premises Licence, the Sub-Committee must take such steps as are considered appropriate to promote the licensing objectives;

- i) The Prevention of Crime and Disorder
- ii) Public Safety
- iii) The Prevention of Public Nuisance
- iv) The Protection of Children from Harm

3.2 The options are to;

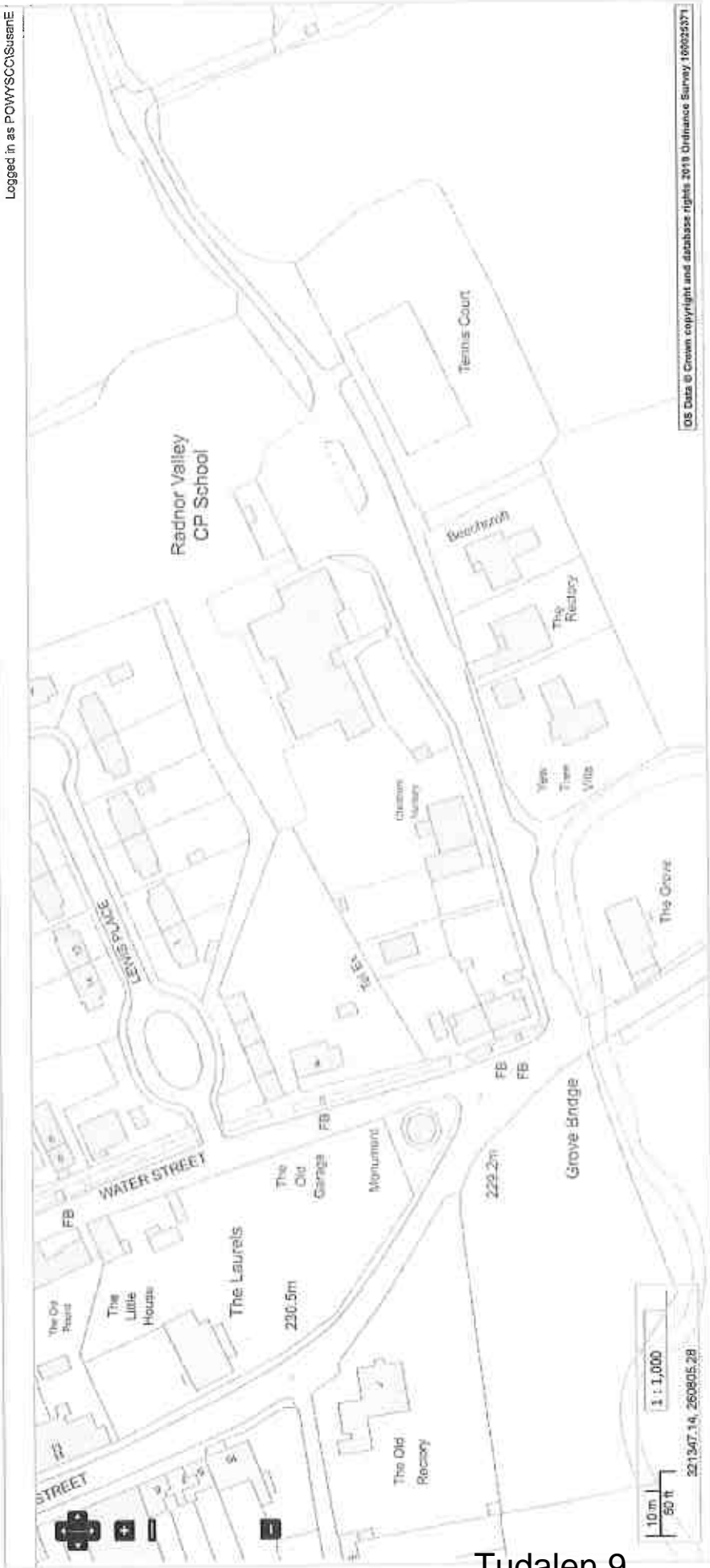
- a) grant the application for a licence as submitted by the applicant for the relevant licensable activities, conditions offered by the applicant and inclusion of mandatory conditions made under the Licensing Act 2003 or
- b) grant a licence with modified conditions; or
- c) reject the whole or part of the application.

4. DETERMINATION

4.1 The Licensing Sub-Committee is requested to determine the application and take steps appropriate to promote the Licensing Objectives.

There are fire extinguishers throughout the premises which are checked and serviced annually. Exits are clearly marked. The outside area is fenced and gated. The building is well maintained and does not pose a hazard.

d) The prevention of public nuisance

The type of activity held at the Old School is felt be low risk from public nuisance. However, there will always be a responsible person overseeing attendance and dealing with offenders in a calm and diplomatic manner.

e) The protection of children from harm

We intend to operate a challenge 21 policy on purchase of alcohol by young people. Children must be accompanied by an adult at all times. Where an event is held specifically for children, it will be ensured that organisers will be fully DBS checked. There will be no sale of alcohol during school hours. A record of refusals to serve alcohol will be kept.

In terms of specific **regulated entertainments** please note that:

- **Plays:** no licence is required for performances between 08:00 and 23:00 on any day, provided that the audience does not exceed 500.
- **Films:** no licence is required for 'not-for-profit' film exhibition held in community premises between 08:00 and 23:00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- **Indoor sporting events:** no licence is required for performances between 08:00 and 23:00 on any day, provided that the audience does not exceed 1000.
- **Boxing or Wrestling Entertainment:** no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08:00 and 23:00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- **Live music:** no licence permission is required for:
 - o a performance of unamplified live music between 08:00 and 23:00 on any day, on any premises.
 - o a performance of amplified live music between 08:00 and 23:00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08:00 and 23:00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08:00 and 23:00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.

Thank you for the copy of your application received in respect of the above.

Having had the opportunity to look at the application as it stands at present, and with reference to my recent telephone conversation with Ms Watson, I would have no alternative but to object to the application for the following reasons:

There is insufficient information in your application to promote the Public Safety objective.

Suggested conditions which would resolve the objection would be to apply the following conditions in the interests of public safety:

30 milliamp residual current device protection will be provided to electrical sockets used for public entertainment equipment. Portable residual current devices are not acceptable as protection.

A satisfactory electrical installation report will be provided.
Inspection and testing of the electrical installation at the premises shall be carried out by an Approved Electrical Contractor (competent person) prior to the event. An approved contractor means a contractor approved by the National Inspection Council for Electrical Installation Contracting (NICEIC), the Electrical Contractors Association (ECA), National Association of Professional Installers and Testers (NAPIT), or other such contractor certified for such inspection and testing under the Electrotechnical Assessment Scheme.

The inspection and testing must cover the electrical installation in public areas of the premises. The Approved Contractor shall make a report or issue a compliance certificate that identifies (i) which parts of the installation have been inspected and tested, (ii) the results of the inspection and testing, (iii) any work necessary to ensure that the electrical installation is safe.

I am writing to strongly object to the above license application under the 2003 Act – The Protection of Children from Harm.

The Old School, New Radnor have applied for an alcohol license 12 noon – 11pm Mon – Sun which the majority of their opening times/licensing times clashing with School Hours and the children also using the New Radnor Play Park in School Lane.

New Radnor, along with a number of other areas, have ongoing issues with Drink drivers. This is something that does go on and due to lack of police presence goes undetected. The premises has already been used over the Christmas break, under the TENS License and I am concerned drink driving from the premises has already taken place. The turning circle for vehicles down School Lane brings them directly outside the school entrance and the Play park of New Radnor. Having a venue with an Alcohol license adjacent to a Primary School puts significant risk to the children and therefore is relevant to one of the most important licensing objectives set out at the beginning of the 2003 Act:

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance;
- the protection of children from harm.6 protection of Children.

I will also be in dicussion with the relevant department as already over the short period of time The Old School has already held events, we have seen people/vehicles attending the Old School events creating issued with parking. The Primary School has clear NO PARKING yellow lines which were put in place by Powys Council due to a childs near miss with a car, again due to vehicles parked

directly outside the School. These no parking lines are repeatedly ignored within and outside of School hours, still causing significant risk to the protection of Children. If and when the license is granted this will only increase the problems further.

I would appreciate your comments regarding this matter and ask that the Alcohol license is refused or the licensing hours significantly reviewed.
