LICENSING ACT 2003

Licensing Sub-Committees – Procedural Guidelines for the conduct of hearings in accordance with the Licensing Act 2003 (Hearings) Regulations 2005 (“the Regulations”)

Introduction

The four licensing objectives, as set out in the Licensing Act 2003 are:

- **The prevention of crime and disorder**
- **Public safety**
- **The prevention of public nuisance**
- **The protection of children from harm**

Each application that comes before a sub committee of the Authority will be treated on its own merits and this licensing authority will take its decision based upon the merits of the application, taking into account the need to promote the four licensing objectives. This Authority will also have regard to its Statement of Licensing Policy and the guidance issued under section 182 of the Licensing Act 2003.

1. The hearing will normally be held in public. However, the sub committee may exclude the public from all or part of a hearing where it considers that the public interest in so doing outweighs the public interest in the hearing, or that part of the hearing, taking place in public.
2. The hearing shall take the form of a discussion led by the Licensing sub committee and cross examination will not be permitted except at the discretion of the sub committee if it is required to consider the application or representations. This is in accordance with Regulation 23 of the Regulations. A party wishing to cross examine another party must make an application to the sub committee.
3. The procedure at the hearing shall be determined by the sub committee, normally in accordance with the following guidelines.
4. The sub committee shall appoint a Chairman.
5. The Chairman will welcome everyone to the hearing and will introduce him/herself and the other members of the sub committee.
6. The Legal Adviser to the sub committee will ask everyone present to introduce themselves and will explain the procedure to be followed. He/she will ask the applicant, if unaccompanied, if he/she was aware of the right to be represented. The sub committee will also consider any

- request made by a party under Regulation 8(2) for permission for another person to appear at the hearing as a witness.
7. The Licensing Officer will present a report outlining the nature of the application to be considered, any relevant representations and policy statements. The sub committee may ask any relevant questions of the officer through their Legal Adviser.
 8. The applicant (or his/her representative) will be invited to put his/her case. The applicant may call witnesses to support the case provided that the sub committee have given permission to do so. The sub committee and other parties who have made relevant representations may ask any relevant questions of the applicant or of persons representing them. The sub committee should ask questions through their Legal Adviser.
 9. The Chairman will then invite those parties making representations to address the sub committee. The sub committee may ask relevant questions of those parties making representations through their Legal Adviser. The applicant or his/her representative may also ask relevant questions of those parties making representations.
 10. The Chairman will invite the applicant (or his/her representative), and any parties making representations, to briefly summarise their points if they wish.
 11. The sub committee may ask relevant questions of any party during the hearing through their Legal Adviser, but should refrain from any discussion of the merits of the case.
 12. The sub committee will retire with their Legal Adviser to deliberate in private. If it is necessary to recall any party to provide further information or clarification, all parties at the hearing will be asked to return.
 13. When the sub committee has reached its conclusion, the parties will be recalled and the decision will be announced to the applicant by the Legal Adviser to the sub committee, accompanied by, as appropriate, a description of any conditions which are to be attached to the grant of a licence and the licensing objectives that they relate to. Reasons will be given for the decision. That information will also be given to the applicant in writing as soon as is practicable and he/she will be told of any statutory rights of appeal that are available. In cases where a decision cannot be given at the end of a hearing, the applicant and those parties present will be notified of the decision within five working days.

PLEASE NOTE:

- Any person attending the hearing, who, in the opinion of the Chairman, is behaving in a disruptive manner, may be required to leave.
- Late additions to representations and evidence will only be considered with the agreement of all parties present
- The sub committee may allow a maximum period of time for each party to make all relevant statements in support of their written representations. The sub committee would request that all parties avoid repetition and keep the discussion moving in the interests of efficiency.
- Decisions will generally be taken regardless of whether the applicant or those who have made written representations are present. All notices and written representations received from absent parties will be considered. However if a party is unable to attend a hearing due to unforeseen circumstances and would wish to be present, that party should contact the relevant Licensing Officer or Committee Clerk by telephone in order to explain the circumstances. In such a case, the sub committee may be prepared to adjourn the hearing.

SUBJECT: Application for a Premises Licence

REPORT FOR: DECISION

1. APPLICATION

On 13/12/18, an application for a Premises Licence was received from Alan Murphy trading as Mach 1 Leisure Limited for a Café Bar and Grill, with alcohol sales and music at the Old Barclays Bank Building, 4 Heol Pentrehedyn, Macynlleth.

1.2 A location map of the premises is set out at **Annex A**, and a copy of the application and a plan of the premises are reproduced at **Annex B**.

The Proposed Premises is located in the former Barclays Bank Building, behind the Clock Tower in Machynlleth. The premise comprises of a ground floor and the applicant has submitted plans which also show a previously unused basement, which will also include licensable activities.

1.4 The applicant & The Licensing Authority satisfied procedural obligations by consulting the Responsible Authorities and advertising the application.

1.5 The Applicant has applied for a Premises Licence authorising the sale of alcohol, as well as recorded music.

2. REPRESENTATIONS

The list of all Representations made by the Responsible Authorities are contained within **Annex C**.

2.1 Responsible Authorities

Fire Service (Caren Wells)

Concerns over Means of Escape; Travel Distances; Occupancy Numbers; Building Control Consultations and lack of information contained within application.

Environmental Health (Paul Bufton)

Mr Bufton expressed concerns that the proposed premises is part of a building already occupied by residents (flats above the licensed premises) and noise may be transmitted, which will have an impact on residents

Insufficient detail within the application to demonstrate that noise from the premises can sufficiently be controlled to prevent public nuisance.

Police (Rod Bowen – Police Licensing Officer)

Although the Police did not make Representations, following a meeting with the applicant during the Consultation period, the Police Licensing Officer requested some amendments to the Licence, which the applicant agreed to. Therefore, the licence application has now been amended to the following hours –

2.2 Other Persons

Representations were received from 4 local residents. Concerns were raised over Public nuisance (noise / disturbance) and Crime and disorder (anti-social behaviour) and public safety (lighting / fire safety).

These letters are all shown in **Annex D**.

3. OPTIONS

3.1 In determining the application for the Premises Licence, the Sub-Committee must take such steps as are considered appropriate to promote the licensing objectives;

- The Prevention of Crime and Disorder
- Public Safety
- The Prevention of Public Nuisance
- The Protection of Children from Harm

3.3 The options are to;

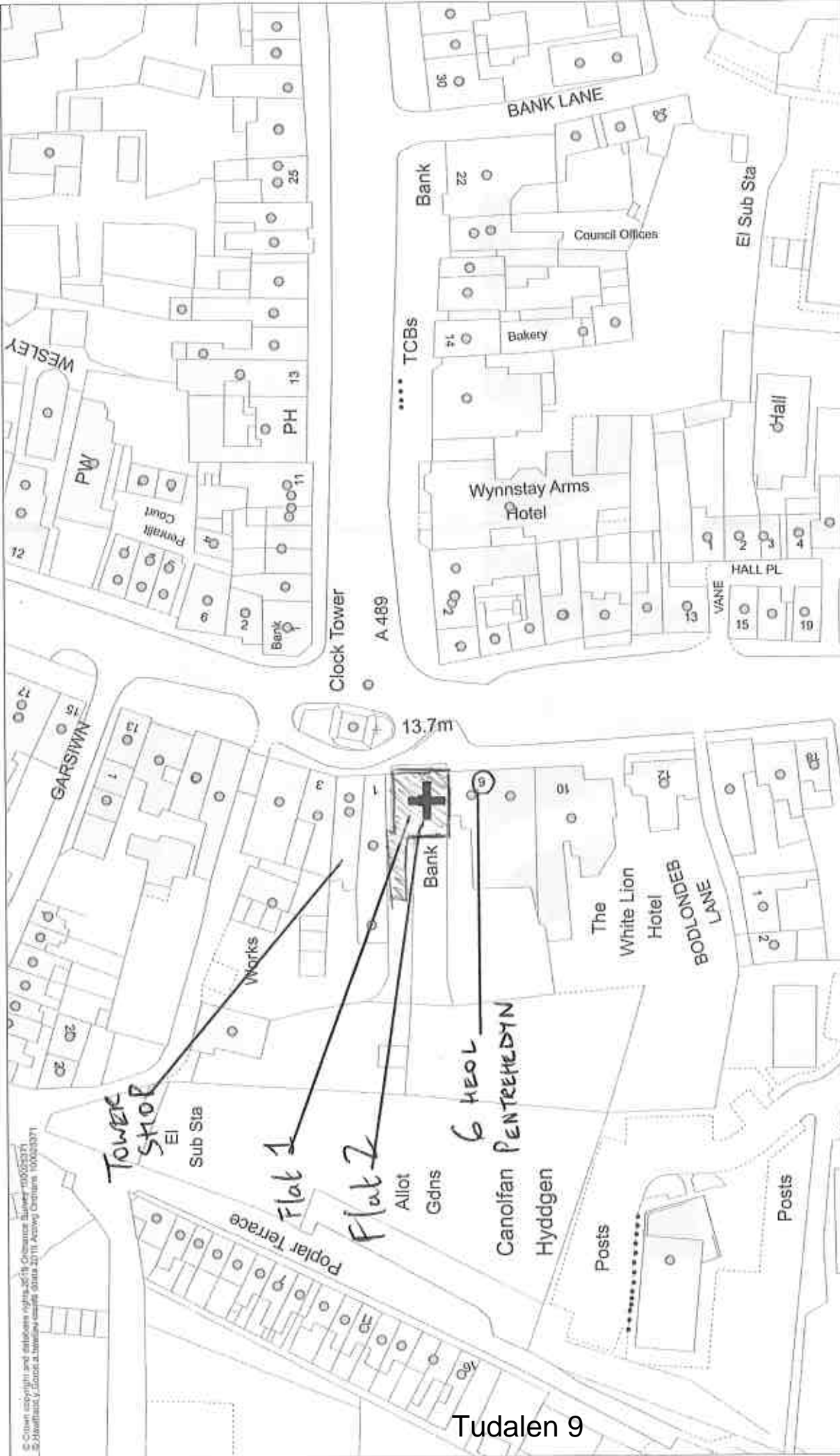
- a) grant the application as submitted by the applicant without modification, with the exception of the inclusion of mandatory conditions made under Section 19, Licensing Act 2003 (Supply of Alcohol); or
- b) grant a licence with modified conditions; or
- c) reject the whole or part of the application.

4. DETERMINATION

4.1 The Licensing Sub-Committee is requested to determine the application.

TO PROMOTE ALL FOUR LICENSING OBJECTIVES WE WILL KEEP:

Strong management controls and effective training of all staff so that they are aware of the premises license and the requirements to meet the four licensing objectives with particular attention to:

- a/ no selling of alcohol to underage people.
- b/ no drunk and disorderly behavior on the premises area.
- c/ vigilance in preventing the use and sale of illegal drugs at the retail area.
- d/ no violent and anti-social behavior.
- e/ no harm to any children.

Display the operating Schedule providing the hours of operation and licensable activities during those hours.

Designated premises supervisor will be in day-to-day control of the premises, to provide good training for staff on the Licensing Act keeping appropriate training records, to make or authorise each sale.

- Operate and display "Challenge 25" information to prevent the supply of alcohol to under-age drinkers.
- Operate a CCTV system installed with recording device.
- Premises will be secured locked outside of all authorised trading times.

As experienced licensed premises operators we know that it is necessary to carry out our businesses with a purpose of promoting these objectives. We promise to support these objectives throughout our operating schedule.

b) The prevention of crime and disorder

A CCTV System with recording will be installed to monitor entrances, exits, and other parts of the premises in order to address the prevention of crime objective.

Clear and legible notices will be placed visible from outside the premises indicating the normal hours of operation under the terms of the premises license and operating schedule during which licensable activities are permitted.

Clear and conspicuous notices will be placed warning of the consequences antisocial behavior.

Not selling of alcohol to drunk or intoxicated customers.

Custom will not be sought by means of personal solicitation outside or in the vicinity of the premises.

Prevention and vigilance in illegal drug use on or in the close proximity of the premises.

Staff will be well trained in asking customers to use premises in an orderly and respectful manner and to intervene as soon as behavior becomes unacceptable.

c) Public safety

Fixed internal and external general lighting and emergency lighting will be provided to promote the public safety objective.

Well trained staff will ensure adherence to environmental health requirements.

Staff will be trained and will implement Challenge 25 underage ID checks.

A log book shall be kept upon the premises in which shall be entered particulars of all matters related to any public safety condition attached to the premises license. The log book shall be kept available for inspection when required.

All parts of the premises and all fittings and apparatus therein, door fastenings and notices, lighting, emergency lighting, automatic fire alarm, heating, electrical, air conditioning, sanitary accommodation, other installations and escape routes, will be maintained at all times in good order and in a safe condition.

d) The prevention of public nuisance

Noise reduction measures will be implemented to address the public nuisance objective.

Prominent, clear and legible notices will be displayed at the exit requesting the public to respect the needs of nearby

residents and to leave the premises and the area quietly.

Deliveries of goods necessary for the operation of the business will be carried out at such a time or in such a manner as to prevent nuisance and disturbance to nearby residents.

Disposal of waste, particularly glass bottles, will be carried out at such a time or in such a manner as to prevent nuisance and disturbance to nearby residents.

The Licensee will ensure that staff who arrive early morning or depart late at night when the business has ceased trading at times outside the operating schedule conduct themselves in such a manner to avoid causing disturbance to nearby residents.

Customers will be asked not to stand around loudly talking in the street outside the premises.

The movement of bins and rubbish outside the premises will be kept to a minimum after 11.00pm. This will help to reduce the levels of noise produced by the premises.

Any lighting on or outside the premises will be positioned and screened in such a way so as to not cause a disturbance to nearby residents.

Adequate waste receptacles for use by customers will be provided in the local vicinity.

e) The protection of children from harm

"Challenge 25" will be operated and anyone who is over 18 but looks under 25 will be asked for acceptable ID (a card bearing the PASS hologram, a photographic driving license or a passport) if they wish to buy alcohol.

Staff will be fully trained in the requirements for age restrictions. Alcohol will not be sold to anyone under 18 years of age.

As our operation is not intended to be used 'exclusively or primarily' for the supply of alcohol then refreshment will be available to school children, sixth form and A Level students by way of eat-in or take-out sandwiches, snacks, hot beverages and soft drinks between 10:00hrs and 18:00hrs Monday to Sunday.

We will implement our own children's policy for the premises after 18:00hrs Monday to Sunday:-

• AFTER 18:00hrs ALL CHILDREN UNDER THE AGE OF 16 MUST BE ACCOMPANIED AND SUPERVISED BY AN ADULT WHILST ON THE PREMISES

For their own safety and protection WE FURTHER REQUIRE that children under the age of 12 are

- PROPERLY SEATED AT A TABLE
- NOT LEFT UNSUPERVISED
- NOT TO RUN AROUND
- NOT TO APPROACH THE BAR
- NOT TO PLAY ON THE FLOOR
- NOT TO LEAVE TOYS ON THE FLOOR
- PREFERABLY ESCORTED TO WC'S BY A RESPONSIBLE ADULT

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

- A certificate of registration or naturalisation as a British citizen, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.

- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A **current** Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 17(3) or 18A (2) of the Immigration (European Economic Area) Regulations 2006, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
 - evidence of the applicant's own identity – such as a passport,
 - evidence of their relationship with the European Economic Area family member – e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,

- **Indoor sporting events:** no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- **Boxing or Wrestling Entertainment:** no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- **Live music:** no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and

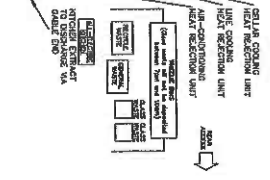
DETAIL 'A'

BASEMENT PROPOSED LAYOUT



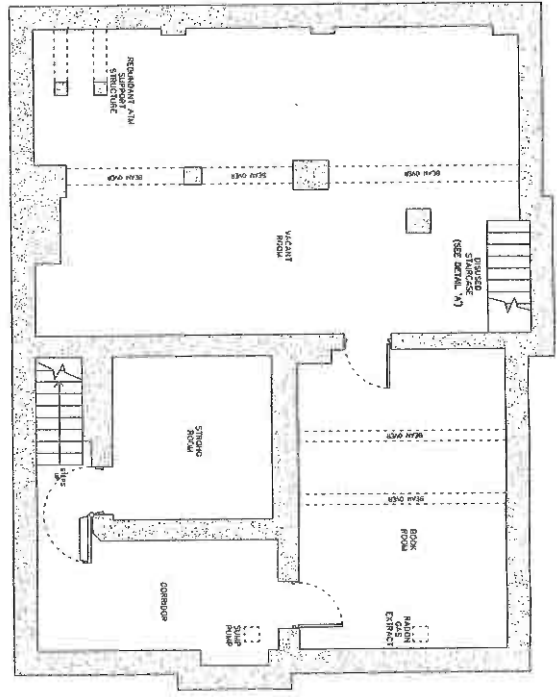
GROUND FLOOR PROPOSED LAYOUT

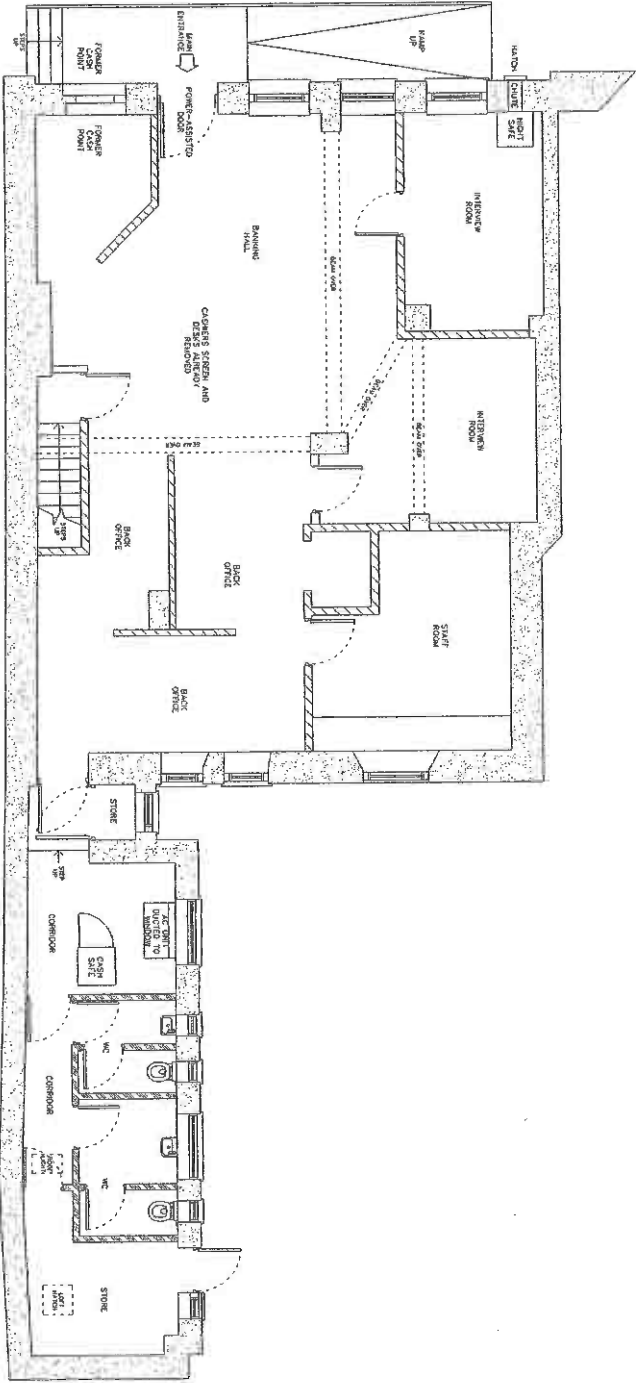


BASEMENT EXISTING LAYOUT

- **Any tables or chairs on the forecourt area at the front of the premises shall not be used by customers after 9pm to have any meals or an area to consume alcohol.**
- **Any children aged 16yrs or under shall be accompanied and supervised by an adult after 6pm when on the premises and this include the forecourt area.**

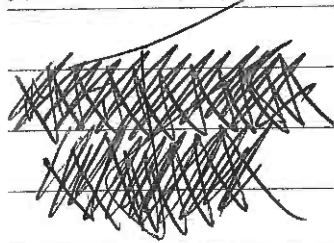

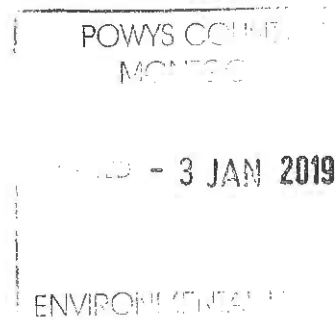


I note that this application was dated 06.12.2018



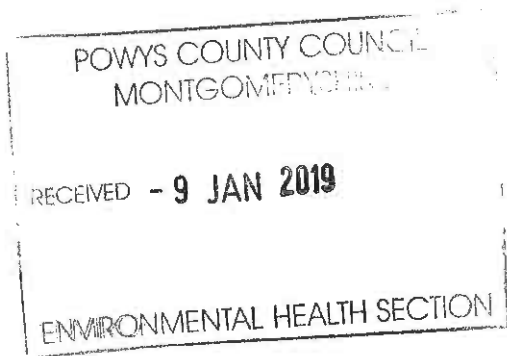

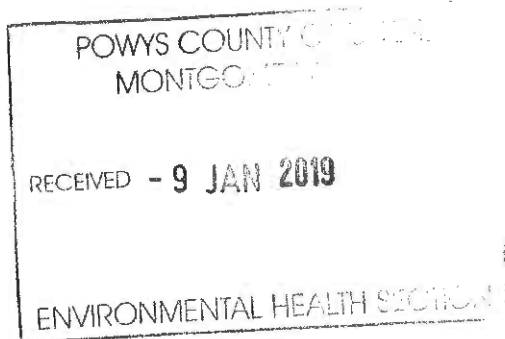

Re licence application for Mach 1 Leisure at Former Barclays Bank Building, 4 Heol Pentrerhedyn, Machynlleth SY20 8DN

As a neighbour living directly above the proposed bar/grill I must register my absolute objection to this licence as detrimentally and profoundly affecting my right to enjoy my home. Please note I am not the only householder living directly above, these changes would affect my next door neighbours and their landlord as profoundly as they affect me.

I have voiced all of my concerns to the Planning Office with regards to Change of Use so I shall keep this objection specific to your four areas of concern as licencing officer. I've never had to make objections like this before so I hope you will ask me for further clarity if required and that I'm putting my concerns correctly under the appropriate headings and you will be understanding if not.

1) The prevention of Crime & Disorder

Aside from the general concern of late licencing hours and what behaviour might entail from prolonged drinking sessions, I note with alarm that the applicant has withdrawn himself from The B.O.B.B scheme in Machynlleth and feel that is indicative of someone not taking drink-related antisocial behaviour seriously. I also note the problems and complaints they had during their brief tenure at The Red Lion last year alongside more serious recent incidents at their current property The White Lion as recently as 22/12/18 when police were called to an incident involving weaponising of a bottle. Such behavior proceeds from drunkenness that if turned a blind eye to constitutes a threat to public safety. Even a proposal to join the BOBB scheme for the purpose of obtaining this licence strikes me as a disingenuous move given actual track record.

2) Public Safety

The concerns raised above I feel also overlap here. Furthermore the property is on a busy junction with no crossing, I feel that presents a hazard to clientele leaving the premises after a few drinks. There will also be no second exit in the event of a fire.

The access to my property is via an unlit unadopted alleyway of some length, this is also a cut through to other residential areas. I feel with the licenced property so close by that this alleyway

will become more frequently used by customers at night. There are already problems with people urinating and vomiting in this alleyway and I fear more frequent use will exacerbate the situation many fold. I have further concerns for my personal safety using this alleyway at night if I am to encounter drunk men there.

3) The Prevention of Public Nuisance

This is my largest area of concern. As a one of two households directly above and several more in close proximity the late night noise from within and outside the property that this licence, if granted, would facilitate would be extremely detrimental to our quality of life. To this end I detail the concerns I raised with the Planning Officer over noise nuisance:

i) Noise at the front of the property which would be audible from my main living area and one of my childrens' bedrooms from sources such as: customers entering and leaving well into early hours of the morning, taxis/cars picking up and dropping off well into early hours, people occupying chairs and tables proposed by the clock, smokers congregating under the clock, deliveries of barrels and other supplies.

ii) Inside the building:

- noise below my main living area, plans show bar directly underneath
- noise from customers (58 seats + undisclosed standing capacity), staff & recorded music into the early hours.

iii) Back & outside of property

The Kitchen will effectively be in the shared garden and will make this space unusable in the way in which one usually expects to enjoy a garden.

- proposed extractor fan & 3 heat rejection units in operation well into the early hours if not 24/7 will be a noise and odour nuisance (concerns echoed by environmental health in their initial submission) that will make the garden unusable.
- kitchen door: in conversation with Alan he said this would either be fully open or with fly screen. In either of these scenarios (and in the event of it being closed), me and my neighbours will be subject to noise of staff, music/radio and cooking late into the night. This will also affect one of my children, whose bedroom directly overlooks. Having worked in commercial kitchens myself I'm fully aware of the noise they entail and that no doubt there will be staff hanging outside the back door taking breaks, smoking etc. in the shared garden thus destroying its privacy.
- windows opening onto the garden will pass out noise from customers and recorded music

4) The protection of children from harm

I understand from the licence application that Mr Murphy has pretty much dealt with the general concerns of children inside the licenced premises. However I would add my concerns for my own children having to use the alleyway detailed above on their way home from school, that the staff exit will be open directly onto the garden that my three children use and that their lives will be considerably harmed by the noise generated from a licenced premises beneath their bedrooms.

Furthermore, there is no precedent in Machynlleth for a licensed property with UNASSOCIATED residential property above it. I appreciate Alan's approach to me in explaining his proposal but, I do not think this is the correct building for it and my faith in his goodwill is substantially diminished after seeing his licence application in which, despite words to the contrary, he has applied for a licence well beyond sociable hours (midnight - 1:30 am)

I respectfully request that you reject this licence on the above concerns and the grounds that it is not needed; there are four other late night licenced premises within 30 seconds walk which in a town of around 2000 people strikes me as saturation point and it imposes considerable diminishing effects on all its near residential neighbours.
