SUBJECT: Modification of 7.5 tonne Maximum Gross Weight Order for New Bridge Vyrnwy, Llanymynech to remove prohibition of right turn movements

REPORT FOR: Decision

1. Summary

1.1 The attached Statement of Reasons at Appendix A sets out the reasons for Powys County Council seeking to introduce the modified proposed prohibition of driving Traffic Regulation Order, which is to be funded as part of the ongoing bridge repair project.

2. Proposal

2.1 To introduce a traffic regulation Order which revokes the existing prohibition of right turn movements from the B4393 onto the B4398, whilst retaining the necessary 7.5 tonne structural weight limit until such time that the strengthening works to the flood arches are completed.

2.2 The draft replacement Traffic Regulation Order and accompanying plan are attached at Appendix B.

3. Options Considered / Available

3.1 The only other available option is to retain the existing Traffic Regulation Order that includes the structural weight limit and the prohibition of right turning movements from the B4393 onto the bridge along the B4398. Whilst this option would represent a minimal cost saving to the overall bridge repair scheme, it would retain a traffic prohibition which is no longer required and potentially bring the entire traffic regulation order into disrepute.

4. Preferred Choice and Reasons

4.1 The proposal is the only option to be considered, as it will ensure that the prohibitions relating to the bridge are relevant and legally enforceable.

6.1 Powys County Council has actively engaged with the community council to bring about the repairs to this bridge in a timely fashion, and to ensure that any traffic prohibitions associated with the project are continually reviewed and only introduced/retained as necessary at the various stages of the bridge repair project to address relevant highway safety concerns and to protect the structural integrity of the bridge as the project progresses. The proposals support the CIP priority of improving our transport infrastructure by making it safer for people to use the highways within Powys and for residents and visitors to access residential properties and local facilities.

7.1 The local member for the affected communities of Carreghofa and Llandysilio has expressed support for the proposal. The proposal will not have a significant wider effect on local members in other wards.

(B4398 New Bridge Vyrnwy, Llanymynech)
(7.5 Tonne Maximum Gross Weight Restriction) Order 2019**

STATEMENT OF REASONS

The County of Powys (B4393 & B4398, New Bridge Vyrnwy, Llanymynech) (7.5 tonne Maximum Gross Weight Restriction & Prohibition of Right Turn Movements) Order 2015 was made by Powys County Council on 5th January 2015.

The Order was made to minimise further structural damage to the bridge, improve highway safety by eliminating hazardous traffic movements, whilst reducing traffic disruption to a minimum.

Part of the bridge repair works have now been completed, to the extent that two-way traffic movements can now be accommodated over the bridge; therefore, the right turn prohibition from the B4393 is no longer required.

The 7.5 tonne maximum gross weight restriction is still required over the bridge until such time that the structural repairs to the flood arches are completed. These works are anticipated to be carried out before October 2019, after which time the structural weight limit can be removed.

In the meantime, the Council needs to modify the existing Order to remove the reference to the right turn prohibition but maintain the structural weight limit.

THE COUNTY OF POWYS
(B4398 NEW BRIDGE VYRNWY, LLANYMYNECH)
(7.5 TONNE MAXIMUM GROSS WEIGHT RESTRICTION) ORDER 2019

WHEREAS POWYS COUNTY COUNCIL (“The Council”) being the highway authority for the length of road described in Article 2 of this Order is satisfied that the weight and movements of all vehicles passing along the said length of road should be restricted by virtue of safety; and weaknesses in the structural condition of the undermentioned bridge which carries that length of the B4398.

NOW THEREFORE the Council in exercise of its powers under Sections 1(1) and 2(1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1. In this Order the term “maximum gross weight” shall have the same meaning as in The Traffic Signs Regulations and General Directions 2016.
2. No person shall cause any vehicle the maximum gross weight of which exceeds seven and a half tonnes to proceed in that length of the County Classified Road Number B4398 in the Communities of Carreghofa and Llandysilio which is carried by New Bridge over the River Vyrnwy (Ordnance Survey Grid Reference SJ 25329 19635).
4. The County of Powys (B4393 & B4398, New Bridge Vyrnwy, Llanymynech) (7.5 tonne Maximum Gross Weight Restriction & Prohibition of Right Turn Movements) Order 2015 is hereby revoked.
4. This Order shall come into operation on the **XXXth** day of **XXX** 2019 and may be sited as The County of Powys (B4398 New Bridge Vyrnwy, Llanymynech) (7.5 tonne Maximum Gross Weight Restriction) Order 2019.
5. The plan annexed hereto is for the purposes of identification only.

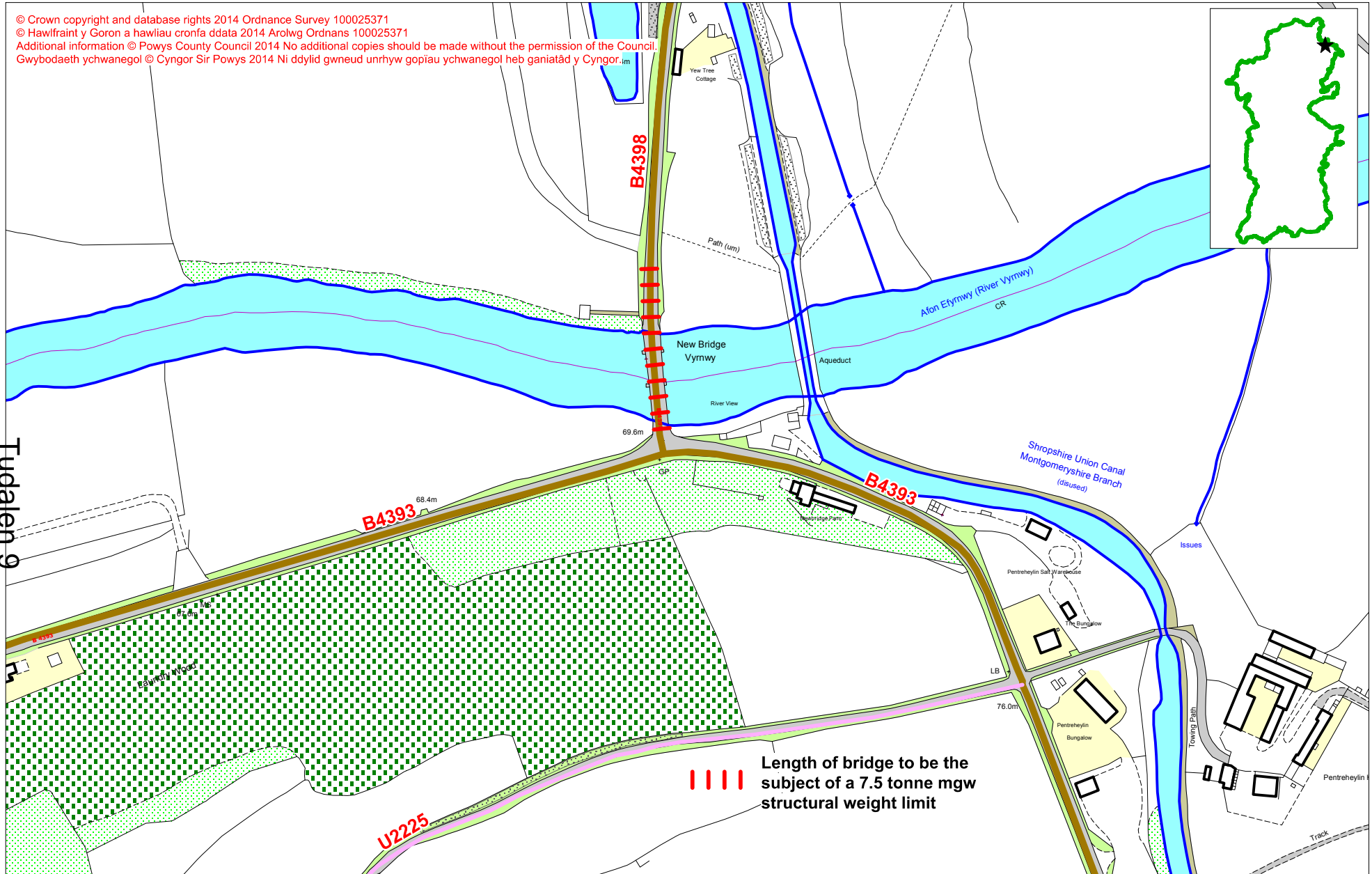
