- continued to document all pot holes within Yscir and maintained pressure on Powys County Council to repair them,

- attended all meetings held by Llanfihangel Nant Bran & Trallong, Merthyr Cynog and Yscir community councils,
- made myself available to all residents at any time via phone/email/messenger, rather than holding surgeries. I normally plan a meeting to visit residents to hear concerns or answer queries within a day or two of being contacted,
- put forward and had amendments to the budget passed to enable councillors to monitor future budgets more effectively and start working on a better funding formula to hopefully reduce the chance of high council tax increases for my ward.
