Section 2: Constituency activity

During the year I:

- worked with the Welsh Government and an Internet Service Provider (Dyfed IT) to roll out a superfast broadband internet service for all residents within my ward,
- started a process of documenting all pot holes within Ysgir and maintaining pressure on Powys County Council to repair them,
- attended litter picks with Ysgir community council,
- attended all meetings held by Llanfihangel Nant Bran & Trallong, Merthyr Cynog and Ysgir community councils,
- made myself available to all residents at any time via phone/email/messenger, rather than holding surgeries. I normally plan a meeting to visit residents to hear concerns or answer queries within a day or two of being contacted,
- contacted Powys County Council asking them to add more farmers with suitable equipment to the list of approved contractors to be used in the event of high quantities of snowfall,
- requested speed monitoring tests be applied to various roads within Ysgir, this was carried out quickly. I am also in the process of starting a SpeedWatch project in the ward and
- requested a speed limit be applied on the Sennybridge to Brecon main road in Nant Y Gwreiddyn.
