4. **Draft Statement of Intent.**  
6. **Public Consultation Exercise – Budget – Scrutiny Observations.**

**Documents Considered:**

- Statement of Intent 2014-17 (2015 Update)
- Feedback on Budget Consultation Meetings from Members of the Joint Chairs Steering Group and Scrutiny Officers.
- Cabinet Report 11<sup>th</sup> November, 2014 – Budget / Community Delivery public events.

**Issues Discussed:**

- The draft Statement of Intent is an update to the planning and review process rather than a wholesale rewrite of the document. The public's response during the recent consultation exercise is only one of the issues considered in developing the One Powys Plan.
- Disappointment regarding the attendance at the public consultation meetings and it was felt that the meetings were a waste of time and would not be repeated.
- Need to treat the public's comments with caution, and in future a need for more clear options to be available for the public to consider which will be drawn from the Statement of Intent, but the Cabinet will also need to give greater direction.
- Need to consider the use of focus or user groups in future as possible alternative means of consultation.
- In previous years a more detailed list of options was provided, this year was probably set at too high a level. There is also a probable need to engage on specific matters where there might be a higher level of public interest. A web based tool is being considered for consultation on the budget.
- This year's process is about refining the One Powys Plan – did the public engagement tell us anything to change the plan fundamentally? – probably not.
- Need for the Council to have a better consultation process. Local Members were not well informed about what message the Council is trying to convey and there is confusion also amongst Town and Community Councils. The public do not understand the severity of the level of cuts.
- The focus of planning by the Council continues to be next year rather than looking forward to the end of the decade. Steps are being taken with the Cabinet to develop a 2020 vision. There are examples of good ways of working differently which need to be highlighted.
- The Council needs to look more at growing the economy in Powys thus growing the numbers of jobs available. The focus of the strategic joint needs assessment has been on poverty and the economy.
- The Statement of Intent is the first 6 pages of the document with the remainder being the supporting evidence.
- A question was asked whether the aim of the Council to have the community delivery of services was not being delivered as the Council rather than transferring leisure services to community groups was seeking a commercial partner.

**5. Scrutiny Comments to Cabinet and right of scrutiny chairs to speak at Cabinet meetings.**

**Issues Discussed:**

- Scrutiny chairs paid to attend Cabinet meetings. New constitution provides the right for scrutiny chairs to speak at Cabinet meetings.
- Currently the scrutiny chair can speak with the permission of the Leader.
- Libraries scrutiny review document – information not imparted effectively to the Cabinet at the meeting as restriction on the chair speaking. If this is the way for the future, the process will need to be reviewed.
- Council Solicitor has spoken to the Leader who has indicated that he is happy for the scrutiny chairs to speak as long as they ask him in advance. The Leader also wants to give parity to both scrutiny chairs.
- There are instances at Cabinet meetings where relevant matters could be brought to the attention of the Cabinet during the debate, and it is hoped the Leader would allow the relevant scrutiny chair to speak.

**Outcomes:**

- **Leader's comments should resolve previous difficulties with scrutiny chairs speaking at Cabinet meetings.**
