In previous meetings when the Bryngydfa application has been discussed I have declared a prejudicial interest on the grounds of close personal association. This was because of my relationship to one of the directors of the Bryngydfa company, my father and the mother of the director concerned were first cousins. I am also friendly with the other directors. This I believed was covered in section 5 of the Code, C(i).

Given the recent problems that the Community Council had experienced with regard to Code of Conduct issues (of which Powys County Council are aware) I decided that to avoid any future challenges I would do this despite feeling that the presence of a prejudicial interest was borderline and due to the most part to local lack of confidence in the workings of the Community Council. This resulted in my feeling I would almost inevitably fail the public perception test.

I would like to point out though that as a local farmer who has spent all his life in the valley I am friendly with the vast majority of the local residents and have connections with very many of them.

This Ward has already lost the representation of three Councillors who have had to declare an interest in the Bryngydfa matter, two are directors of the Company and the other has a close friendship with one of those directors. Local residents feel that there will be no one from their Ward to present their views at the Council meeting. Whilst I appreciate Members from the Knucklas Ward could be approached those who have spoken to me are reluctant to do this and would prefer to be able to speak to a Member from their own Ward.

The Bryngydfa development is situated at the far point of the Beguildy Community area, some miles from the Knucklas Ward at the opposite end.

I have no direct connection with wind energy developments myself and have no current plans to do so.

I feel that the granting of a dispensation for me to take full part in the above items would enable me to represent residents of the Beguildy Ward.
