#### A. Members' Code of Conduct

## A1 Adoption of the new Model Members' Code of Conduct by Town and Community Councils

#### B1. Town and Community Councillor Referrals

**B1.1** Since the last meeting one new referral to the Ombudsman has been notified. The substance of the complaint was that a member of the public who was critical of the actions of a Clerk was an associate of the Councillor complained about. The Ombudsman has decided not to investigate the complaint concluding that the conduct complained of does not, in fact, constitute a breach of the Code which is designed to reflect the actions taken by Elected Members in their own right and not the actions of third party associates.
