A. Referral of Councillors to Public Services Ombudsman

A1. Town and Community Councillor Referrals

The Ombudsman has advised that one new Code of Conduct Complaint has been received (ref 1/11TCC). The Ombudsman has decided not to investigate the complaint as he did not believe on the basis of the information provided that the Councillors behaviour could be said to be sufficient to amount to a breach of the Code of Conduct.

B. Dispensations

B1. Applications - Town and Community Councillors

B1.1 Llanbadarn Fynydd

Three applications have been received from Councillors at Llanbadarn Ffynnydd Community Council. The applicants are seeking dispensation on the grounds that 5 out of 7 Community Councillors have an interest in matters relating to windfarms. The Clerk has been asked to provide further information which has not been submitted to date.

B1.2 School Modernisation Interests

Two applications have been received from Presteigne and Norton Town Councillors Jennie Simpson and John Kendall. Copies of the applications are attached to this report for information.

The Standards Committee at its meeting in July 2010 granted a dispensation to County Councillors (who will be decision makers) to speak and vote at meetings of the County Council in relation to the Schools Modernisation Programme, subject to certain caveats. A copy of this minute is attached for information. These application are likely to be the first of many on behalf of Town and Community Councillors in relation to this subject, and the Sub-Committee is requested to consider whether a blanket dispensation should in addition be granted to Town and Community Councillors (who will not be decision makers) to speak and vote on this issue at Town and Community Council meetings.

B1.3 Scottish Power Energy Networks proposal to Connect Windfarms to the National Grid.

Scottish Power and the National Grid are currently undertaking a consultation exercise in relation to the connection of windfarms in Powys to the National Grid, which will involve the installation of an electricity hub together with associated pylons. This project will predominantly affect Montgomeryshire but will also have an impact on Radnorshire.

Following conversations with the clerk to one Town and Community Council in Montgomeryshire regarding the issue of Members' interests, the impact this could have on councillors' individual and collective ability to discuss these issues became apparent, including the possibility of Councils being inquorate for consideration of these items. Due to the scale of the proposal, it is also apparent that a large number of Town and Community Councils could be affected as indicated above, and therefore it was considered appropriate that the Sub-Committee's view be sought as to whether a blanket dispensation should be granted to Town and Community Councillors to speak and / or vote on these proposals.

In addition the question of County Councillors who are also Town and Community Councillors and who may also be members of the County Council's Planning Committee (who it is understood will be the decision making body in relation to the electricity hub) needs to be considered and this matter is raised separately on the main Standards Committee report.
