The Working Group thank the Leader, the Head of Transformation and Communications and officers for attending scrutiny.

Scrutiny make the following observations:

- The report is a great improvement on previous reports and officers were congratulated for that improvement.
- The Working Group noted that following previous year's comments from scrutiny comparative information relating to the previous year's performance had been included in this year's report.
- It was accepted that there was additional improvement action being undertaken by the Council such as the work being undertaken by the Improvement and Assurance Board and the Transformation Board.

JC	The 7 well being goals are mentioned in the introduction but you have to go to an appendix to find them. Might be useful to have them upfront as they are key to the plan.	Accepted The Goal descriptors have been moved from the Appendix to Page 3.
JC	I think it might be fair to say that COVID-19 did impact on this plan but only for about 3 weeks of the entire year. Is it worth mentioning this?	Accepted The Leader's intro has been amended to say that covid-19 impacted in the last quarter of the year.
JC	I am confused about the number of "new Primary Schools" in Gwenyfed catchment on page 6 which says 5 new schools were opened? Should that be new build not new schools?	Accepted The Statement in the Leader's intro has been amended to reflect this comment.
