County Councillor Timothy Van-Rees declared a personal non pecuniary interest in item CC104 – 2016 Brecon Barracks as the Chairman of the Executive Committee of the Trustees of The Royal Welsh Regimental Museum.

4.	CALL IN OF PORTFOLIO HOLDER DECISION DATED 13TH OCTOBER 2016 ON CAR PARKING CHARGES	CC100- 2016

The Solicitor to the Council explained that the Portfolio Holder for Highway's decision to make a Traffic Regulation Order to introduce car parking charges at a number of sites had been called in by 5 members of the Place Scrutiny Committee. The Solicitor and Section 151 Officer had agreed that there were procedural irregularities with the decision making process in that there was no impact assessment produced and had allowed the call-in to proceed. The call-in had been considered by the Place Scrutiny Committee who had decided to refer the matter to the full Council.

A number of Members spoke against the introduction of car parking charges in their towns and communities. Some raised specific concerns in respect of car parks in their communities and criticised the lack of an impact assessment. A number argued that car parks should either be handed over to Town and Community Councils to run or they should receive a proportion of the income. Other Members were concerned that any shortfall in income should not be made up by increasing charges in car parks where there were already charges.

The Portfolio Holder for Highways reminded Members that the proposals to increase income from car parking by £30,000 were part of the budget approved by Council in February 2015. If the charges were not raised they would have to be found elsewhere and he also reminded Council that the Highways, Transport and Recycling Service had to find £5m in savings. The Portfolio Holder advised that it was his intention that the issue should be referred back to Cabinet and in those circumstances the Solicitor to the Council advised the Cabinet to abstain from voting.

Councillor Curry left the meeting at 11.40.
Councillor George joined the meeting at 11.50.

County Councillor Gary Price proposed

1. That full Council refer the decision back to Cabinet.
2. In a policy of fairness and equality that the Cabinet abandon its proposals on car parking charges of the 9th September 2015 and undertake a full review of all car parks and parking charges within the County in full consultation with Town and Community Councils.

This was seconded by County Councillor Garry Banks.

Council adjourned from 12.00 – 12.30 for the political groups to consider the proposal.

The first proposal was put the vote and passed by 32 votes to 0 with 3 abstentions.

RESOLVED that full Council refer the decision back to Cabinet.

The second proposal was put to the vote and was lost by 18 votes to 20 with 1 abstention.

Councillors John Brunt, Sue McNicholas, Huw Williams left the meeting at 12.45 p.m.

5.	WELSHPOOL TOWN PRIMARY EDUCATION	CC101- 2016

The Portfolio Holder for Education outlined his recommendations to Cabinet in respect of primary school education in Welshpool.

- It is proposed that the new English-medium School will be located on land at Welshpool High School. The school will, however, operate from the current sites of Ysgol Maesydre, Gungrog and Oldford Schools on a temporary basis before subsequently transferring to the new building at the earliest opportunity;
- The new build Welsh-medium School will be located on the Ysgol Maesydre site, but will operate from the current site of Ardwyn School on a temporary basis before subsequently transferring to the new building;
- The anticipated timescale is for the new schools to be established from September 2017 before transferring into the two new school buildings upon their opening in 2018/19;
- The current four schools in Welshpool – Ardwyn Nursery & Infant School; Gungrog CiW Nursery & Infant School; Oldford Nursery & Infant School and Ysgol Maesydre would close from the end of August 2017.

297 written responses had been received during the consultation period. 91% of staff (11) responding supported the proposals, 100% of governors (14), 84% of parents (63), and 55% (209) of other respondents. Of these a proportion came from the Wales Humanists Association who had encouraged their supporters to oppose the proposal for the English-medium primary school to be a Church in Wales school. As many of the responses were anonymous it was not clear how many were from Welshpool or Powys and how many came from out of the county.

County Councillor Francesca Jump spoke as a local member to say that she fully supported the proposals. She did ask for extra transport to be provided for pupils and for more information on improving the walkways to the schools. The Head of Schools agreed to discuss this with colleagues to ensure safe routes and integrated transport.

County Councillor Phil Pritchard spoke as a local member. He fully supported the establishment of new English medium and Welsh medium schools but was concerned with some aspects of the proposals, principally about the sites selected and he asked for the Cabinet to visit the sites. He would prefer to have seen a non-denominational school created rather than a Church in Wales school. The Head of Schools noted that any significant changes to the proposals would require a new consultation and submission of a new business case.

County Councillor Myfanwy Alexander also raised the question of the denomination of the school noting that many Roman Catholic Eastern European families lived in the area. She asked whether it would be possible for them to be provided with free transport to a Catholic school. The Head of Schools advised that the transport policy did not currently allow for this. The policy would be reviewed but he could not guarantee that it would change. He also noted that Church in Wales schools provided the same religious education syllabus as other non-denominational schools.

County Councillor Gary Price expressed disappointment that many of the Cabinet were not in attendance. The Monitoring Officer confirmed that Council's views would be reported to Cabinet. In response to Councillor Price's question about why the consultation had been delayed, the Head of Schools reminded members about the significant number of consultations that had been undertaken by the Schools Service during the year.

County Councillor David Jones asked for consideration to be given to the transport issues and for information on the number of pupils who would be living further away from the new schools as a result of the proposals. The Head of Schools confirmed that transport would be taken into account as part of the planning process.

County Councillor Aled Davies asked about the capacity of early years provision noting that there only 2 additional nursery places. The Head of Schools advised that he was confident that this was sufficient.

County Councillor Gwilym Vaughan welcomed the proposals.

The Leader confirmed that the Cabinet would visit the school sites.

By 34 votes to 0 with 2 abstentions Council

RESOLVED to support the proposals being recommended by the Portfolio Holder for Education to Cabinet for the establishment of a new English medium school and a new Welsh medium school in Welshpool.

6.	2018 REVIEW OF PARLIAMENTARY CONSTITUENCIES	CC102- 2016

County Councillor Linda Corfield advised that her community was strongly opposed to being included in a De Clwyd a Gogledd Sir Faldwyn constituency and would prefer to be included in the Brecon, Radnor and Montgomery constituency. She proposed that the response be amended to reflect this, seconded by County Councillor Gary Price.

County Councillor Gwilym Vaughan advised that he would prefer to see the historic constituency of Montgomeryshire retained but that if this was not an

option for the communities of Cadfarch, Glantwymyn, Llanbrynmair and Machynlleth to transfer to Gwynedd rather than De Clwyd a Gogledd Sir Faldwyn. This was seconded by County Councillor Michael Williams.

County Councillor Gillian Thomas left the meeting at 1.58 p.m.

Council voted on Councillor Corfield's proposal and by 27 votes for, 1 against and 3 abstentions

RESOLVED to delete the reference to Forden joining De Clwyd a Gogledd Sir Faldwyn in the Council's response.

Council voted on Councillor Vaughan's proposal and by 14 votes to 8 with 10 abstentions

RESOLVED that the Council's response should state that if Montgomeryshire is not retained the communities of Cadfarch, Glantwymyn, Llanbrynmair and Machynlleth should transfer to Gwynedd rather than De Clwyd a Gogledd Sir Faldwyn.

I welcome the opportunity to submit a question to County Cllr Tony Thomas, Portfolio Holder for Regeneration and Planning, for the Council meeting on 26th January 2017:

My question is:

Could he please identify the particular paragraph of Planning Policy Wales (Edition 9) or the major change in local circumstances, which requires the definition of local search areas and hence provides the justification for the Authority's designation of such "Local Search Areas" as a Further Focussed Change so late in the examination process?

Portfolio Holder's Response

Planning Policy Wales sets out the land use planning policies of the Welsh Government. It makes it clear that PPW is supplemented by Technical Advice Notes, circulars and policy clarification letters (Paragraph 1.1.1, PPW).

Section 12.8 of PPW covers renewable and low carbon energy and states:

Paragraph 12.8.2: *"Planning policy at all levels should facilitate delivery of both the ambition set out in Energy Wales: A Low Carbon Transition and UK and European targets on renewable energy."*

Paragraph 12.8.8: *"The Welsh Government is committed to using the planning system to:*

- *optimise renewable energy generation;*
- *optimise low carbon energy generation; etc."*

Paragraph 12.8.9: *Local planning authorities should facilitate the development of all forms of renewable and low carbon energy to move towards a low carbon economy (see 4.4.3) to help to tackle the causes of climate change (see 4.7.3). Specifically, they should make positive provision by:*

- *considering the contribution that their area can make towards developing and facilitating renewable and low carbon energy, and ensuring that development plan policies enable this contribution to be delivered; etc”*

Although PPW refers to Strategic Search Areas, it refers to local policy (i.e. LDP policy) but does not specifically reference ‘local search areas’. PPW is, however, supplemented by policy clarification letters and such a letter was issued by the Minister for Natural Resources, dated the 10th Dec 2015, to all local planning authorities regarding his expectations for energy policies in local development plans.

The Minister wrote (partial extract):

“I am pleased that, since the publication of our ‘Renewable Energy Toolkit for Planners’ in 2010, many local planning authorities have undertaken Renewable Energy Assessments (REAs) as part of the Local Development Plan (LDP) evidence base. However, it is disappointing to note that no LDP in Wales has taken the results of the REA and formulated local policies (including allocations or areas of search) for local-authority scale (5MW – 25MW) renewable energy schemes or other low carbon technologies.

The designation of such areas would show leadership at the local level; give certainty to the renewable energy industry in making investment decisions; and, through the LDP consultation process, would give communities a say as to where renewable energy developments should be located. By designating these areas, developments can be guided to the most appropriate locations. This approach has been taken by the Welsh Government for large scale wind energy projects through the Strategic Search Areas (SSAs) in TAN8. I expect local planning authorities to take the same, proactive approach for all forms of renewable and low carbon energy generation.”

To conclude, PPW requires Local Authorities through their development plan policies to facilitate all forms of renewable and low carbon energy and to consider the contribution that their area can make towards developing and facilitating renewable and low carbon energy, and ensure that their development plan policies enable this contribution to be delivered.

The policy clarification letter from the Minister for Natural Resources in Dec 2015 sets out the expectation for local authorities to include allocations or areas of search within local development plan policy. It therefore provides clarity that an LDP’s renewable energy policy should be shown spatially on the proposals map.

This position was reflected in the comments dated 11th March 2016 made by Welsh Government to the Council in response to the consultation on proposed Focussed Changes to the LDP. [1084 WG Letter](#)

REPORT FOR: **Decision**

1. The Independent Remuneration Panel for Wales sets the level of fees payable to all Independent and Co-Opted Members of the Council. However it is for the Council to determine if it wishes to set a maximum number of days for which an Independent or Co-Opted Member can be paid.
2. With regard to the Independent Member of the Audit Committee the Council in January 2015 set the maximum number of days for which the Independent Member can be paid at 25 days. However for the current financial year there have been a number of circumstances which have increased the requirement for the Independent Member to attend an increased number of meetings. In the previous financial year the Independent Member was a member of the Audit Committee, the Audit Committee's Internal Audit Scrutiny Group, and the Finance Scrutiny Panel. During this financial year the Independent Member was appointed by the Audit Committee as its Vice-Chair and in addition a new scrutiny group has been established to review the overspend in social care which has resulted in a number of additional meetings being called.
3. The cumulative impact of this increased workload has resulted in the Independent Member exceeding the 25 days maximum allowed by the Council (to the end of December 2016 the total claimed was 29 days, with the extra days taking place in December 2016). However it is important to retain the valuable contribution provided by the Independent Member in the ongoing work until the end of this Council term. This one-off cost of approximately £3250 for an estimated 16 extra days (December 2016 to April 2017) can be contained within the current year's budget, but such additional expenditure will require the consent of Full Council.
4. In the circumstances, Full Council is asked to consider removing the maximum number of payments to the Independent Member for the remainder of the Council term only (i.e. until the end of April, 2017) so that he can continue to contribute to the work of the Council. The maximum level of 25 days per annum as set in 2015 will continue to be applied from May 2017 onwards, unless varied by Full Council at a later date.

5. Comments on the Report.

5.1 Support Services.

Finance – This one-off cost can be contained within the existing budget

Legal – I note the Finance comment and have nothing to add as the report properly highlights the relevant information regarding the matter.

5.2 Corporate Communications.

No proactive communication action required

5.3 Statutory Officers.

Strategic Director – Resources (Section 151 Officer) – The recommendation is supported to ensure continuity until the end of April 2017.

Solicitor to the Council (Monitoring Officer) has commented as follows: “I note the legal comment and have nothing to add to the report”.

5.4 The Chair of Audit has commented “As chair of the audit committee I fully support this interim measure to secure continuity at a very important and intense time for the audit committee. Mr Brautigam as vice chair is involved in a number of highly important issues and has proved to be a very able and well respected member of the committee. This proposal will also give us the continuity which is required as we move towards the budget setting and the scrutiny of it by the audit committee and finance scrutiny panel”.

SUBJECT: Question from County Councillor Huw Williams

In a Powys County Council news release, dated the 24th of November 2016, it was stated that, 'the Council is considering buying Ladywell House, Newtown, as part of an overall strategy to reduce building ownership...'. This news release goes on to say, 'buying Ladywell House is part of a long term strategy to reduce building ownership and reduce the number of buildings, in the area.'

As part of the business plan, specifically which other buildings have been identified and considered for disposal, 'to reduce building ownership'? This purchase, according to the news release, will also enable the Council to, 'reduce its revenue costs by vacating other buildings, with the potential of a substantial capital receipt from the future sale of some of the redundant buildings'? Are these unidentified 'other' buildings located in Newtown and/or further afield? Is the purchase of Ladywell House dependent on capital receipts from the sale of these 'other buildings', or, is this an aspirational and separate matter?

In answer to your question, at this early stage of the Council's office rationalisation project no specific buildings have been identified for closure. However the Council does need to reduce its costs and increase the efficiency and effectiveness of its use of its office accommodation. One way this can be achieved in the future is to identify properties that may be surplus to the Council's needs, possibly because they are require modernisation but are beyond reasonable repair or perhaps because we no longer deliver our services in such a way that these locations are required. The purchase of Ladywell House is not directly dependent upon the receipt of capital from the sale of (as yet unidentified) properties.
