SUBJECT: Increase in charges for Community Based Services

REPORT FOR: Decision / Discussion / Information

1. <u>Summary</u>

The maximum charge for Community Based Social Care Services is set by the Welsh Government. It is currently £70 per week and has been since April 2017.

The maximum charge will increase to £100 per week by the end of the current Assembly Government in 2021. This increase is part of the Taking Wales Forward Commitment.

There is likely to be an incremental increase each financial year. Welsh Government plan to announce the increase prior to April annually in readiness for the start of each financial year.

Welsh Government have announced an increase to the maximum charge from £70 to £80 per week for April 2018. Cabinet approved in March 2018 that future increases in line with Welsh Government maximum charge increases should be agreed by a portfolio holder delegated decision.

This report proposes that Powys increase the maximum charge from £70 to £80 per week with effect from 14th April 2018. This report further proposes to increase the maximum charge annually on 1st April from 2019 until 2021 in line with the maximum set by the Welsh Government.

2. <u>Proposal</u>

This report recommends Powys increases the maximum weekly charge for Community Based Social Care Services, in line with the set maximum charge set by the Welsh Government to £80 per week with effect from 14th April 2018. This report further proposes to increase the maximum charge annually on 1st April from 2019 until 2021 in line with the maximum set by the Welsh Government.

3. Options Considered / Available

Option 1

That Powys increases the maximum charge from £70 to £80 per week in line with the Welsh Government maximum charge for community-based services and to follow the Welsh Government's increases annually up to 2021.

Option 2

The maximum charge remains at £70 per week.

The recommended option is Option 1.

Increasing the charge in line with the Welsh Government set maximum amount will maintain the sustainability of the service.
