# PORTFOLIO HOLDER DECISION BY THE LEADER May 2018

**REPORT AUTHOR:** Head of Democratic Services

SUBJECT: Delegation of Highways Functions as from 17<sup>th</sup> May,

2018

REPORT FOR: Decision

#### 1. Summary

The County Council on 25<sup>th</sup> January, 2018 decided to cease the operation of the Area (Shire) Committees as from the Annual Meeting of Council on 17<sup>th</sup> May, 2018. Some Highways Functions are currently delegated to Area (Shire) Committees by the Cabinet, and as such alternative arrangements for those functions will need to be established to take effect from 17<sup>th</sup> May, 2018.

#### 2. Proposal.

- 2.1 Even though the Council has decided to cease the operation of the Area (Shire) Committees, the Leader is responsible for delegating any functions. Therefore the Leader will need to review the delegation of the current functions to the Area (Shire) Committees otherwise those functions will revert to the Leader upon the removal of the Area (Shire) Committees.
- 2.2 The functions currently delegated to the Area (Shire) Committees are set out in the Appendix 1 to the report.
- 2.3 The Leader can retain the function set out in appendix 2 or delegate those functions to a Portfolio Holder, officer or other committee. It is suggested that the Leader delegates those Highways Functions coloured yellow in Appendix 2 to the Portfolio Holder for Highways, Recycling and Assets and those Highways functions coloured Green in Appendix 2 to the Portfolio Holder Finance, Countryside and Transport as from 17<sup>th</sup> May, 2018.
- 2.4 In making that delegation to the Portfolio Holder, the Leader would require that the relevant Portfolio Holder consult with the local Member within whose electoral division the decision fell regarding the proposal. However the relevant Portfolio Holder solely will make the final determination in all cases.
- 2.5 The Constitution will also require amendment to take account of these changes as set out in appendix 2 to the report.
- 2.6 The Highways Service has also requested that the level of delegation (currently £50,000 for the Shire Committees) be increased to £100,000 for Portfolio Holders.

- 2.7 The Council's virement rules (set out in Rules 16.87 to 16.100 of the Constitution), states that there is delegation to a Head of Service to exercise virement for budgets within their control for amounts within £25,001 and £100,000, and that any sums over £100,001 require approval of the Cabinet.
- 2.8 Portfolio Holders are able to take any decision on a matter which falls within their portfolio areas. However, other than where a budget virement is required, there is no financial restriction on the delegated authority of a Portfolio Holder. Therefore setting an upper limit is un-necessary in this instance. Portfolio Holders are also required to comply with the provisions of Rule 13.107 of the Constitution which includes compliance with the Council's Financial Procedure Rules, Contracts Procedure Rules and the Policy and Budget framework set by the Council in taking any decisions.
