**1. Purpose**

- 1.1 To consider the Instrument of Government following a decision by the governing body of Maesyrhandir CP School on the 14th May 2020 to adopt an amended Instrument of Government.
- 1.2 The report contains a recommendation to ratify an amended Instrument of Government for Maesyrhandir CP School.
- 1.3 The report is supported by the revised Instrument of Government, appendix A.

**2. Background**

- 2.1 The Government of Maintained Schools (Wales) Regulations 2005 required all school governing bodies to review and adopt revised Instrument of Government (Instruments of Government are the legal documents that detail the composition of a school governing body). The Authority approved all revised Instrument of Government with effect from 3<sup>rd</sup> October 2006.

Maesyrhandir CP School opted for the composition as outlined below: -

4 parent governors  
3 LA governors  
1 teacher governor  
1 staff governor  
3 community governors  
1 additional community governor  
The headteacher

The amended Instrument of Government would be

5 parent governors  
4 LA governors  
2 teacher governors  
1 staff governor  
4 community governors  
1 additional community governor  
The headteacher

The Instrument of Government would increase by 1 parent governor, 1 LA governor, 1 teacher governor and 1 community governor.

2.2 The governing body of Maesyrrhandir CP School have recommended the increase in their Instrument of Government to strengthen the representation from the local community.

### **3. Advice**

3.1 It is proposed that the governing body of Maesyrrhandir CP School increase its composition from 14 governors to 18 governors.

### **4. Resource Implications**

5.1 Legal: The increased number of Governors is permitted by Regulation 13 of The Government of Maintained Schools (Wales) Regulations 2005.

**1. Purpose**

- 1.1 To change the official school name of Llandrindod Wells CP School, Cefnlllys.
- 1.2 The report contains a recommendation to change the official school name to Ysgol Cefnlllys.

**2. Background**

- 2.1 To consider the request from the governing body of Llandrindod Wells CP School, Cefnlllys at their governing body meeting on the 13<sup>th</sup> July 2020 to change the official school name.

**3. Advice**

- 3.1 It is proposed that the governing body of Llandrindod Wells CP School, Cefnlllys change the official school name to Ysgol Cefnlllys.

As we now have a new permanent headteacher we will need to make a number of changes to signage and letter headings so making this change at the same time will minimise any costs on the school budget.

## **8. Integrated Impact Assessment**

## **9. Recommendation**

It is proposed that the official school name of Llandrindod Wells CP School, Cefnlllys be changed to Ysgol Cefnlllys.
