REPORT TITLE: A4811 Llanidloes Road, Newtown - Partial Speed Limit

Reduction from 40 mph to 30 mph

REPORT FOR: Decision

1. Purpose

To introduce a permanent Traffic Regulation Order to modify the speed limit along the developed frontage of the A4811 Llanidloes Road in Newtown between the college/theatre site and the Pavillion Court housing estate from 40 mph to 30 mph.

2. Background

- 2.1. Powys CC has been awarded £200,000 grant funding to extend the existing shared use path on Llanidloes Rd to the college and theatre thereby completing on of the key arterial Active Travel routes through Newtown.
- 2.2. As part of the plans it will be necessary to widen the path under Nantoer bridge which currently presents significant safety concerns for pedestrians and cyclists (particularly young people walking to and from the college).
- 2.3. The preferred solution is to use one of the existing traffic lanes to create the extra space for vulnerable users thereby reducing the existing live carriageway to one lane.
- 2.4. This will be controlled by means of a programmed traffic control system.
- 2.5. At present this area falls within sections of 40mph zone. To ensure safety on approach and through the traffic control it is felt necessary to extend the existing 30mph limit to include areas that currently have a residential and community facility frontage.
- 2.6. The proposed speed limit Order and the associated signage will be funded as part of this project.

- 2.7. The proposed speed limit modification proposals are attached to this report at Appendix A.
- 2.8. The proposed speed limit modification is compliant with the Welsh Assembly Government Circular No. 24/2009 "Setting Local Speed Limits in Wales", and the proposed speed limit modification is supported by the police, the town council and the local ward county councillors.

3. Advice

- 3.1 No other options are available for consideration at this stage of the Traffic Regulation Order proposal process.
- 3.2 The proposal is part of Powys County Council's activities to pursue the extension of the existing shared use path on Llanidloes Rd to the college and theatre to complete one of the key arterial Active Travel routes through Newtown. The Council is continuing to engage with local residents and stakeholders who will be affected by the proposal. The introduction of this traffic regulation order is required to safely facilitate these works and to address existing concerns regarding high traffic speeds along the A4811 on the approaches to side road junctions and past residential properties and community facilities along this route. The proposals support the CIP priority of improving our transport infrastructure by making it safer for people to use the highways within Newtown and to encourage active travel movements.

4. Resource Implications

- 4.1 All costs associated with legal consultation process, the implementation of the Traffic Regular Order and the manufacture/erection of the associated signage will be funded by the WG grant for the active travel scheme.
- 4.2 The Head of Financial Services (Section 151 Officer) notes the above and can support the recommendation.

5. Legal implications

- 5.1. The Principal Legal Assistant (North) has reviewed the proposals and confirms it is within our powers.
- 5.2. The Head of Legal and Democratic Services (Monitoring Officer) has commented as follows: "I note the legal comment and have nothing to add to the report".

6. Data Protection

6.1. The proposal does not require the processing of personal data, therefore comments from the Data Protection Officer are not required.

7. Comment from local member(s)

7.1. The proposal affects that part of the A4811 class 1 county highway located within the Newtown Central and Newtown South wards. The local members have expressed support for the proposal, as have Dyfed-Powys Police.

8. Integrated Impact Assessment

8.1. An impact assessment is not required.

THE COUNTY OF POWYS (A4811 LLANIDLOES ROAD, NEWTOWN) (30 MPH SPEED LIMIT) ORDER 2021

POWYS COUNTY COUNCIL in exercise of its powers under Sections 82 and 84 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby makes the following Order:-

- This Order may be cited as The County of Powys (A4811 Llanidloes Road, Newtown) (30 MPH Speed Limit) Order 2021 and shall come into operation on the XXth day of XXX 2021.
- 2. In this Order;
 - "exempted vehicle" means:-
 - a) any vehicle being used by the emergency services for the purposes described in section 87 of the Road Traffic Regulation Act 1984;
 - b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds; "special forces" means those units of the home forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director.
- 3. No person shall drive any vehicle, other than an exempted vehicle, at a speed exceeding thirty (30) miles per hour on that length of road specified in the Schedule to this Order.
- 4. The County of Powys (Newtown Bypass Side Roads) (30 and 40 mph) and (Revocation) Speed Limit Order 2019 is hereby varied to reflect the speed limit modifications made under this Order along part of the A4811 Llanidloes Road.
- 5. The status of "restricted road" as defined in Section 81 of the Act which applies to the lit section of that length of road specified in the Schedule to this Order is hereby removed.
- 6. The plan annexed hereto is for the purposes of identification only.

SCHEDULE

Length of road subject to 30 mph speed limit

a) That length of the A4811 county classified highway known as Llanidloes Road which extends from a point approximately 146 metres west of its junction with the U4242 county unclassified highway Pavilion Court, in a south westerly direction to a point approximately 255 metres to the west of its junction with the C2025 county classified highway Heol Ashley at the college roundabout.


