**1. Purpose**

- 1.1 To consider the Instrument of Government following a decision by the governing body of Caersws CP School on the 29<sup>th</sup> November 2021 to adopt an amended Instrument of Government.

In line with legislation the governing body composition would reduce to an Instrument of Government for a primary school with less than 100 registered pupils. The current number of pupils on roll was 71.

- 1.2 The report contains a recommendation to ratify an amended Instrument of Government for Caersws CP School.
- 1.3 The report is supported by the revised Instrument of Government, appendix A.

**2. Background**

- 2.1 The Government of Maintained Schools (Wales) Regulations 2005 requires all school governing bodies to review their Instrument of Government (Instruments of Government are the legal documents that detail the composition of a school governing body). The Authority approved all revised Instrument of Government with effect from 3<sup>rd</sup> October 2006.

Caersws CP School opted for the composition as outlined below: -

4 parent governors  
3 LA governors  
1 teacher governor  
1 staff governor  
3 community governors  
1 additional community governor  
the headteacher

The amended Instrument of Government would be

3 parent governors  
2 LA governors  
1 teacher governors  
1 staff governor  
2 community governors  
1 additional community governor  
the headteacher

The Instrument of Government would reduce by 1 parent governor, 1 LA governor and 1 community governor.

### **3. Advice**

3.1 It is proposed that the governing body of Caersws CP School reduce its composition from 14 governors to 11 governors.

## 1. SCHOOL

The name of the school is Caersws C.P. School.

## 2. CATEGORY OF SCHOOL

The school is a community school.

## 3. NAME OF GOVERNING BODY

The name of the Governing Body is Caersws C.P. School  
Governing Body.

## 4. COMPOSITION OF GOVERNING BODY

The governing body shall consist of:

- a) 3 parent governors
- b) 2 LA governors
- c) 1 teacher governor
- d) 1 staff governor
- e) 2 community governors
- f) 1 additional community governor - *appointed by Caersws Community Council*
- g) the headteacher (except at any time when he/she has given written notice to the clerk to the governing body of the school that he/she chooses not to be a governor).

## 5. TOTAL NUMBER

11 (except any time when the headteacher has given notice that he/she chooses not to be a governor, when the total number of governors will be 10).

## 6. DATE OF IMPLEMENTATION

Pursuant to regulation 37 of the Government of Maintained Schools (Wales) Regulations 2005, this instrument of government comes into effect:

- (i) on the date of making for the purpose of reconstituting the governing body;
- (ii) on xxxx for all other purposes.
