Apologies for absence were received from County Councillor S Cox.

#### 2. MINUTES

The Leader was authorised to sign the minutes of the last meeting held on 9<sup>th</sup> May 2023 as a correct record.

#### 3. DECLARATIONS OF INTEREST

There were no declarations of interest reported.

#### 4. WELSHPOOL C.IN.W PRIMARY SCHOOL PROJECT VIREMENT

Cabinet considered a request for additional funding of £150,000 for the Welshpool Church in Wales Primary School Project. The funding would be taken from the unallocated amount currently held within the school's capital budget.

The report set out in detail the reasons why the project had gone over budget. It was proposed that a full review be undertaken and the results shared with the Cabinet, the Transforming Education Programme Board and the Capital Working Group of the Governance and Audit Committee.

Local Member County Councillor Graham Breeze welcomed the proposal to review the reasons why the project had gone over budget. He said that an apology was owed by those who had delayed the scheme to those children who had missed the opportunity to be taught in the new schools but noted that Welshpool now boasted two of the best schools in Wales which served as an example of what schools transformation could achieve.

County Councillor Richard Church, who was another Welshpool Councillor, noted that there were positive lessons to learn as well, and he hoped that other parts of the county would benefit from having high quality schools through the continuation of the schools transformation programme.

#### RESOLVED

## Tudalen 1

- 1. that £150,000 is allocated to the Welshpool C.in.W Primary School project to cover the outstanding costs. This funding will be taken from the unallocated amount currently held within the school's capital budget.
- 2. that a full review of lessons learnt is undertaken, to include both the Welshpool school projects, and that this is shared the Governance and Audit Committee's Capital Working Group.

#### 5. BIODIVERSITY AND RESILIENCE OF ECOSYSTEMS DUTY, SECTION 6 OF THE ENVIRONMENT (WALES) ACT 2016 - 2022 REPORT

Cabinet considered a report setting out the ways in which the Council was meeting its legal duties to maintain and enhance biodiversity under the Environment (Wales) Act 2016, known as a Section 6 report, in the period between December 2019 and December 2022. This aligned with the Council's Corporate Improvement plan aims of 'Stronger, Fairer, Greener.'

The knowledge of specialist officers was key to underpinning ongoing delivery against the duties under section 6 of the Act and the Council had been able to fund a Biodiversity officer and a Nature Recovery Officer post through grants.

The Cabinet Member for a Greener Powys noted that in addition to the activities outlined in the report, a conference was taking place on 14<sup>th</sup> June for Town and Community Councils to help them understand and meet their Section 6 responsibilities and that a workshop had been held on 22<sup>nd</sup> May for County Councillors.

**RESOLVED** that the contents of the December 2022 revision of the Section 6 report be accepted as reflecting the actions taken to maintain or enhance biodiversity between 2019 and 2022.

## 6. CORPORATE SAFEGUARDING BOARD ACTIVITY REPORT

Cabinet received an update from the Interim Director of Social Services and Housing who chaired the Corporate Safeguarding Board. She reported that good progress was being made against the action plan developed from the recommendations in the Wales Audit Office Safeguarding Audit Report, published in December 2022. The action plan would now be built into the regulatory tracker and reported on during quarterly performance meetings and by the Governance and Audit Committee.

#### 1. Purpose

- 1.1 Further to the decision made by Cabinet on the 7<sup>th</sup> March 2023, the Council published a Statutory Notice proposing the following:
  - To make a regulated alteration to formally establish a Welshmedium stream at Ysgol y Cribarth from September 2023.
- 1.2 The purpose of this report is to inform Cabinet members of the Objections received during the statutory Objection Period, and to determine whether or not to implement the proposal.
- 1.3 The report is supported by the following appendices:
  - Appendix A Statutory Notice
  - Appendix B Objection Report
  - Appendix C Updated Integrated Impact Assessment
  - **Appendix D** Updated Equalities, Community and Welsh Language Impact Assessments

## 2. Background

#### Ysgol y Cribarth

- 2.1 Ysgol y Cribarth is located in Aber-craf, at the north of the Ystradgynlais catchment.
- 2.2 It opened in a new building in 2012 following the reorganisation of all schools in the Ystradgynlais catchment. At this time, the 10 schools in the catchment were merged to create 4 new schools. 3 English-medium schools were established Ysgol y Cribarth, Ysgol Bro Tawe and Ysgol Golwg y Cwm, and one Welsh-medium school was established to serve the catchment area Ysgol Gymraeg Dyffryn y Glowyr.

2.3 The school currently operates as a single stream English-medium school, however since September 2021, the school has also operated a Welsh-medium foundation phase class on a pilot basis, as part of a pilot scheme that was supported by Powys County Council. This class has continued to operate in the 2022/23 academic year. There are currently 20 pupils in the Welsh-medium class.

2.4 Current pupil numbers at the school are as follows<sup>1</sup>:

- 2.5 Following the successful introduction of the Welsh-medium pilot class at the school, an Options Appraisal paper regarding the school's future language category was considered by Cabinet on the 13th December 2022, which identified a preferred option to formally establish a Welshmedium stream at the school.
- 2.6 The formal establishment of a Welsh-medium stream at the school would be in line with the Strategic Aim set out in the Council's Strategy for Transforming Education in Powys to '*improve Welsh-medium provision across all key stages,*' and the Strategic Objective to '*Move schools along the language continuum*'.
- 2.7 Following consideration of the Options Appraisal, Cabinet agreed to carry out consultation on the following proposal:
  - To make a regulated alteration to formally establish a Welshmedium stream at Ysgol y Cribarth from September 2023.

## The Consultation Period

- 2.8 Consultation on the proposal to establish a Welsh-medium stream at Ysgol y Cribarth commenced on the 19<sup>th</sup> December 2022 and ended on the 6th February 2023.
- 2.9 A Consultation Report listing the issues raised during the consultation and the Council's response to them was published. This was considered by Cabinet on the 7<sup>th</sup> March 2023.

2.10 At the meeting on the 7<sup>th</sup> March 2023, Cabinet agreed to proceed with the process to formally establish a Welsh-medium stream at Ysgol y Cribarth through the publication of a Statutory Notice.

## **Statutory Notice**

2.11 Further to the decision made by Cabinet on the 7<sup>th</sup> March 2023, the Council published a Statutory Notice proposing the following:

'To make a regulated alteration to formally establish a Welsh-medium stream at Ysgol y Cribarth, School Road, Abercraf, SA9 1XD.

This will be introduced on a phased basis from 1st September 2023, building on the Welsh-medium pilot class which currently operates at the school. '

- 2.12 The Statutory Notice was published on the 19<sup>th</sup> April 2023 for a period of 28 days, in accordance with the guidance within the School Organisation Code (2018). A copy of the Statutory Notice is attached as Appendix A.
- 2.13 The objection period ended on the 17<sup>th</sup> May 2023.

## **Objections**

2.14 1 objection was received during the statutory objection period. This is summarised in the Objection Report which is attached as Appendix B, along with the Council's response to the issues raised.

## 3 <u>Advice</u>

- 3.1 Having considered the objection received, it is recommended that the Council proceeds with implementation of the proposal to establish a Welsh-medium stream at Ysgol y Cribarth, as outlined in the Statutory Notice (Appendix A).
- 3.2 The reasons for this are outlined below:
  - Would provide continuity for pupils currently accessing Welshmedium provision at the school
  - Would provide an additional opportunity for pupils in the catchment to access Welsh-medium provision
  - Welsh-medium provision would be more accessible to pupils living in the north of the catchment
  - Pupils at the school would have the opportunity to study through the medium of Welsh and develop full bilingual skills, if they so wished
  - Potential to increase the number of pupils studying through the medium of Welsh in the locality and in Powys

- Potential to increase the pupil numbers at the school
- Would provide continued access to English-medium provision at the school alongside Welsh-medium provision
- Positive impact on the school's Welsh ethos, which could provide more opportunities for English-medium pupils
- Supports the aim in the Council's Strategy for Transforming Education to support schools to move along the language continuum
- Would contribute towards the targets in the Council's WESP
- Would contribute towards the Welsh Government's 2050 target of 1m Welsh speakers
- 3.3 The target would be to implement the change on a phased basis as outlined in the Statutory Notice, starting in September 2023.
- 3.4 It must be noted that proceeding with the proposal to formally establish a Welsh-medium stream at the school does not preclude that school from being a part of future reorganisation proposals.

#### 4. <u>Resource Implications</u>

- 4.1 The foundation phase pilot is currently supported by Transformation funding of £95,000 in 2022-23 and £40,000 in 2023-24 (for the summer term only) which would cease if the Welsh medium stream is formally established. If this is agreed, the school's formula-led delegated funding would increase by approximately £26,500 in 2023-24 (for the 7 months from September 2023 to March 2024) and by a further £37,300 in 2024-25. As another year group joins the Welsh stream in September 2024, formula funding will increase by approximately £26,600 in addition.
- 4.2 In the short-term, initial modelling suggests that the formula-led delegated funding for the school would be approximately £90,000 more per annum than if the school remained a single-medium school. In the medium to long term the additional funding required for transitioning to a dual stream school then falls to £60,000 more per annum than the funding required for a single-medium school.
- 4.3 These additional costs would be funded by savings realised as part of the Strategy for Transforming Education in Powys 2022-2032 that formed part of the 2023-24 approved budget. It should be noted that these are estimated costs based on projected pupil numbers for future years. The actual costs of implementation will depend on the actual pupil numbers attending the school at the time of implementation.
- 4.4 The Head of Finance (Section 151 Officer) notes the report and the funding position as set out in the paragraphs above and can support the recommendation.

## 5. <u>Legal implications</u>

- 5.1 Legal: The recommendation can be supported from a legal point of view
- 5.2 The Head of Legal and Democratic Services (Monitoring Officer); I note the legal comment and support the recommendations."

#### 6. <u>Comment from local member(s)</u>

6.1 No comments received.

#### 7. Integrated Impact Assessment

- 7.1 An initial impact assessment was considered by Cabinet on the 13th December 2022.
- 7.2 In addition, a range of draft impact assessments were produced as part of the consultation documentation. These included an Integrated Impact Assessment, an Equalities Impact Assessment, a Community Impact Assessment and a Welsh Language Impact Assessment.
- 7.2 The draft impact assessments were updated to reflect issues raised during the consultation period and the updated impact assessments were considered by Cabinet on the 7<sup>th</sup> March 2023 when considering whether or not to proceed with the publication of a statutory notice.
- 7.3 These have been further updated following the objection period, and the updated versions are attached as Appendix C and D.

## 8. <u>Recommendation</u>

- To receive the Objection Report in respect of formally establishing a Welsh-medium stream at Ysgol y Cribarth.
- To approve the proposal to make a regulated alteration to formally establish a Welsh-medium stream at Ysgol y Cribarth from September 2023.

# NOTICE OF SCHOOL REORGANISATION PROPOSAL UNDER THE SCHOOL STANDARDS AND ORGANISATION (WALES) ACT 2013

Notice is hereby given in accordance with section 42 of the School Standards and Organisation (Wales) Act 2013 ("the Act") and the School Organisation Code 011/2018 ("the Code"), that Powys County Council of County Hall, Llandrindod Wells, Powys LD1 5LG ("the Council"), having consulted such persons as required, proposes the following:-

- i. To make a regulated alteration to formally establish a Welsh-medium stream at Ysgol y Cribarth, School Road, Abercraf, SA9 1XD.
- ii. This will be introduced on a phased basis from 1<sup>st</sup> September 2023, building on the Welsh-medium pilot class which currently operates at the school.

This means that:

- From 1<sup>st</sup> September 2023, all pupils admitted to the school in the Reception year group will be able to express a preference for the Welsh-medium stream or the English-medium stream.
- In addition, pupils attending the Welsh-medium pilot class which is currently operating at the school will attend the school's Welsh-medium stream from September 2023.
- It is expected that a full Welsh-medium stream (from Reception to Year 6) will operate at the school from September 2026.
- An English-medium stream will continue to operate at the school alongside the Welsh-medium stream.

The school is currently maintained by Powys County Council.

The Council undertook a period of consultation before deciding to publish this proposal. A consultation report containing a summary of the issues raised by consultees, the responses of the Council and the views of Estyn is available on the Council's website: <u>https://en.powys.gov.uk/article/13703/Ysgol-y-Cribarth</u>.

#### Admissions

The Council will continue to be the admissions authority for the school. The proposal will not impact on the admissions number for Ysgol y Cribarth. The admissions number for first time admission to the school would continue to be 21.

From 1 September 2023:

- All pupils admitted to the school in the Reception year group will be able to express a preference for the Welsh-medium stream or the English-medium stream.

Parents may express a preference for another school and the Council will comply with any such expressed preference subject to Section 86(3) of the School Standards and Framework Act 1998.

#### Language Category

Following implementation of the proposal, the language category of Ysgol y Cribarth, as defined by "Defining Schools According to Welsh medium Provision", Welsh Government Information Document No: 023/2007<sup>1</sup>, would be Category 2 – Dual Stream Primary School.

Based on the new Welsh language categories introduced by the Welsh Government in 2023<sup>2</sup>, the school is currently categorised as T2 – Transitional, to reflect the pilot Welsh-medium provision which is currently operating in the school. Following full implementation of this proposal, the expectation is that the English-medium stream at the school would meet the definition for a Category 1 English-medium school, and the Welsh-medium stream at the school would meet the definition for a Category 3 Welsh-medium school.

#### <u>Transport</u>

Transport for pupils attending Ysgol y Cribarth will be provided in accordance with the Council's Home-to-School Transport Policy.

Pupils living in the area served by Ysgol y Cribarth are currently eligible for transport to Welsh-medium provision at Ysgol Gymraeg Dyffryn y Glowyr. Should the Council proceed with formally establishing a Welsh-medium stream at Ysgol y Cribarth, it is acknowledged that it would take some years for this provision to become fully embedded. During this time, pupils living closer to Ysgol y Cribarth would continue to be able to access transport to Ysgol Gymraeg Dyffryn y Glowyr to access Welsh-medium provision in a designated Welsh-medium school. Once Ysgol y Cribarth has a full Welsh-medium stream providing education from Reception to Year 6, any new pupils who live closer to Ysgol y Cribarth would only be eligible for free home-to-school transport to Ysgol y Cribarth.

#### **Implementation**

The proposal will be implemented by Powys County Council on a phased basis, starting in September 2023

Within a period of 28 days after the date of publication of these proposals, that is to say by **Wednesday 17<sup>th</sup> May 2023** any person may object to the proposals.


(This explanatory note does not form part of the Notice but is offered by way of explanation).

- The Council intends to formally introduce a Welsh-medium stream at Ysgol y Cribarth, Abercraf. The Welsh-medium stream would be introduced on a phased basis, building on the Welsh-medium pilot class which currently operates at the school. An English-medium stream would continue to operate at the school alongside the Welsh-medium stream.
- The rationale for the proposal was set out in a Consultation Document which was issued in December 2022. The Council has subsequently published a Consultation Report, which summarises the issues raised during the consultation period and provides the Council's response to these issues. The Consultation Report is available on the Council's website: https://en.powys.gov.uk/article/13703/Ysgol-y-Cribarth
- The intention is that the proposal would be implemented on a phased basis, starting in September 2023, building on the Welsh-medium pilot class which currently operates at the school.
- Following implementation of the proposal, pupils choosing to attend the Welsh-medium stream at Ysgol y Cribarth would develop the skills needed to become fully bilingual, fluent in Welsh and English.

- Transport for pupils attending Ysgol y Cribarth would continue to be provided in accordance with the Council's Home to School Transport Policy.
- Pupils living in the area served by Ysgol y Cribarth are currently eligible for transport to Welsh-medium provision at Ysgol Gymraeg Dyffryn y Glowyr. Should the Council proceed with formally establishing a Welsh-medium stream at Ysgol y Cribarth, it is acknowledged that it would take some years for this provision to become fully embedded. During this time, pupils living closer to Ysgol y Cribarth would continue to be able to access transport to Ysgol Gymraeg Dyffryn y Glowyr to access Welsh-medium provision in a designated Welsh-medium school. Once Ysgol y Cribarth has a full Welsh-medium stream providing education from Reception to Year 6, any new pupils who live closer to Ysgol y Cribarth would only be eligible for free home-to-school transport to Ysgol y Cribarth.
- This proposal would not affect the right of parents to express a preference for other schools.

## Establishing a Welsh-medium stream at Ysgol y Cribarth

## **Objection Report**

## 1. BACKGROUND

Powys County Council has carried out the statutory process on a proposal to establish a Welsh-medium stream at Ysgol y Cribarth.

The proposal is as follows:

• To make a regulated alteration to formally establish a Welsh-medium stream at Ysgol y Cribarth from September 2023.

Consultation on the proposal took place from the 19<sup>th</sup> December 2022 to the 6<sup>th</sup> February 2023. The Council published a consultation report outlining the findings of the consultation exercise.

On 7<sup>th</sup> March 2023, the Council's Cabinet agreed to proceed with the proposal, and a Statutory Notice was published on the 19<sup>th</sup> April 2023. The Objection Period ended on the 17<sup>th</sup> May 2023.

## 2. SUMMARY OF OBJECTIONS RECEIVED

1 objection was received during the statutory objection period.



At present, the catchment area for Ysgol Dyffryn y Glowyr includes the whole of the Maesydderwen catchment. Currently, there is no change to this. As stated in the Statutory Notice, from September 2023, all pupils applying to attend Ysgol y Cribarth in the Reception year will be able to express a preference for the Welsh-medium stream or the English-medium stream. However, pupils living closer to Ysgol y Cribarth will still be able to apply for a place at Ysgol Gymraeg Dyffryn y Glowyr should that be their preference. Any applications will be dealt with in accordance with the Council's admissions policy. The Statutory Notice provides further clarification in respect of the proposed transport arrangements associated with implementation of the proposal, stating that until a full Welsh-medium stream has been established at Ysgol y Cribarth, pupils living closer to Ysgol y Cribarth

		would continue to be able to access home to school to transport to Ysgol Gymraeg Dyffryn y Glowyr, should that be their preference, but that this would change following full implementation of the proposal, at which point, pupils would only be eligible for home to school transport to their nearest Welsh-medium provider, which is in accordance with the Council's Home to School Transport Policy.
		However, the proposal won't be fully implemented until September 2026. Should there be a need to review and amend the catchment of Ysgol Gymraeg Dyffryn y Glowyr, this would be done nearer the time, and the Governing Body of Ysgol Gymraeg Dyffryn y Glowyr would be part of this process.

		The Policy also states in section 1.1. that 'The Council <b>must</b> Promote access to Welsh medium education.'



Powys County Council has carried out the statutory process on a proposal to introduce a Welsh-medium stream at Ysgol y Cribarth. The proposal is as follows:

• To make a regulated alteration to formally establish a Welsh-medium stream at Ysgol y Cribarth from September 2023.

In line with the Council's policy, an Integrated Impact Assessment has been carried out which incorporates the Welsh Language, Equalities, Well-being of Future Generations Act, Sustainable Development Principles, Communication and Engagement, Safeguarding, Corporate Parenting, Community Cohesion and Risk Management. This is provided in a separate file.

The Welsh Government's School Organisation Code (2018) requires local authorities to carry out a Community Impact Assessment in relation to all school reorganisation proposals. For proposals which affect teaching through the medium of Welsh, local authorities are also required to carry out a Welsh Language Impact Assessment.

Powys County Council has carried out the statutory process on a proposal to establish a Welsh-medium stream at Ysgol y Cribarth. The proposal is as follows:

• To make a regulated alteration to formally establish a Welsh-medium stream at Ysgol y Cribarth from September 2023.

#### 2. OBJECTIVES

The Council is proposing to introduce a Welsh-medium stream at Ysgol y Cribarth to provide continued access to Welsh-medium provision for pupils currently attending the Welshmedium pilot class at the school, and to ensure that all pupils attending the school in the future have an opportunity to choose Welsh-medium provision.

The intended benefits of the proposal are as follows:

- Would provide continuity for pupils currently accessing Welsh-medium provision at the school

- Pupils at the school would have the opportunity to study through the medium of Welsh and develop full bilingual skills, if they so wished

The implementation of the proposal would not impact on public transport provision or community safety.

#### ix) Issues raised during the Consultation

Comments were received during the consultation period which related to the proposal's impact on the community. The majority of these comments suggest that the proposal would have a positive impact on the community.

The comments received are listed in full in the consultation report produced in respect of this proposal along with the Council's response to the points raised. The points raised are also summarised below.

#### Positive impact on the community

- There is need for more Welsh-medium provision in the local community
- Children will now be able to have Welsh-medium education at their local school with no need to travel out of their community
- The proposal would support increased use of the Welsh language in the community, and help keep the Welsh language alive

#### Negative impact on the community

• People might not want to live in Abercraf anymore if there was more Welsh in the school and they didn't want to speak Welsh

#### x) Issues raised during the Objection Period

No comments about the proposal's impact on the community were received during the Objection Period.

#### xi) Conclusion

The proposal only proposes changing the language category of Ysgol y Cribarth, by adding a Welsh-medium stream. English-medium provision would continue to be available at the school, and community facilities associated with the school would continue to be available. Therefore it is anticipated that the proposal's impact on the community would be minimal.

This view was supported by comments received during the Consultation period.

# Whether it might be appropriate to provide additional after school facilities at any alternative school to further secure standards in the Welsh language

Should the proposal be implemented, the use of the Welsh language would increase and there would be enhanced opportunities for pupils across all age ranges to take part in Welsh language activities, including after school activities.

There is therefore no need to consider providing additional after school facilities at any alternative school in order to further secure standards in the Welsh language.

# - How parents' and pupils' engagement with any alternative school and any specific language enhancement it offers could be supported

Should the proposal be implemented, all current pupils would be able to continue to receive education through the medium of Welsh or English at Ysgol y Cribarth throughout their time in the school, therefore there would be no change in terms of parents' and pupils' engagement with the school.

#### - Observations provided by the local authority's Welsh medium Education Forum

The following is a summary of observations provided by the local authority's Welsh-medium Education Forum at a meeting held on 12th December 2022:

'The Welsh-medium Education Forum supports the proposal to introduce a Welsh-medium stream at Ysgol y Cribarth from September 2023, on a phased basis, year-by-year, as pupils currently attending the pilot Welsh-medium class move through the school.

This is a positive step that builds on the successful pilot Welsh-medium class which is currently operating at the school, and supports the Council's strategy to improve access to Welsh-medium-education, and the Council's WESP for 2022-2032, which has a target to increase the percentage of year 1 pupils taught through the medium of Welsh from 22% to 36% by 2032. To achieve this, the plan includes a commitment to develop new Welsh-medium primary provision, which includes developing more Welsh-medium provision in the Ystradgynlais catchment area.

Ystradgynlais is an area of Powys where the Welsh language is widely spoken in the community, and the forum is pleased to see a proposal being brought forward which aims to further improve access to Welsh-medium education in this area, building on the success of Ysgol Dyffryn y Glowyr, which has grown significantly since its establishment in 2012.

The Forum is also pleased to note that Ysgol y Cribarth's governing body has indicated its support for the proposal to establish a Welsh-medium stream at the school.

Alongside the introduction of a Welsh-medium stream at the School, it is important that the Council continues with its discussions with those providing early years provision at the school and stakeholders such as Mudiad Meithrin, to ensure a seamless transition from Welsh-medium early years provision to the Welsh-medium provision at the school.

The Forum would also hope that introducing a Welsh-medium stream at the school would be a first step towards the school moving further along the language continuum in the future.

Should the proposal be implemented, the Welsh-medium Education Forum would be happy to work with Ysgol y Cribarth, to support it to move along the language continuum, to ensure that the best possible opportunities are offered to Powys pupils by providing improved access to Welsh-medium provision which will create bilingual citizens.'

#### - How does the proposal fit with the authority's Welsh in Education Strategic Plan

The Council has recently developed a new Welsh in Education Strategic Plan (WESP) for 2022-32, which sets out how it will develop Welsh-medium provision in Powys over the next 10 years, with the aim of meeting the Welsh Government aspiration to increase the number of pupils accessing Welsh-medium education.

The Council's WESP for 2022-32 was approved by the Welsh Government and the Council's Cabinet in July 2022.

The WESP includes an ambitious target to increase the percentage of Year 1 pupils taught through the medium of Welsh from 22% to 36% by 2032. To achieve this, the plan includes

a commitment to develop new Welsh-medium primary provision, and in particular states that

The authority will focus on developing more Welsh-medium provision in the following catchment areas:

- Llanfair Caereinion
- Llanfyllin
- Ystradgynlais
- Brecon
- Llandrindod Wells/Builth Wells
- Newtown
- Llanidloes'

# - Any future actions that will be needed in consequence of the change to continue to comply with the scheme or meet targets in the scheme.

The proposal to change the language category of Ysgol y Cribarth will have a positive effect on the Welsh language. It is not therefore anticipated that any future action will be needed in order to continue to comply with the scheme or its targets.

However, the Council recognises that if the proposal is implemented, it will need to actively monitor progress of the implementation of the change of language category at Ysgol y Cribarth, in order to ensure its success.

#### v) Comments received during the consultation period

A number of comments were received during the consultation period which related to the proposal's impact on the Welsh language.

The comments received are listed in full in the consultation report produced in respect of this proposal along with the Council's response to the points raised, and are also summarised below:

#### Positive impact on the Welsh language

- The proposal would have a positive impact on the Wlesh language in the community
- The proposal would lead to increased use of the Welsh language
- Comments about the positive impact of Welsh-medium education on pupils
- There is demand for Welsh-medium education in the area, as Ysgol Dyffryn y Glowyr is oversubscribed
- Reference to Welsh Government's 'Cymraeg 2050' strategy
- Reference to the benefits of bilingualism
- There would be a positive Welsh language impact on English-medium pupils at the school

#### Concerns / queries

- The proposal should be to establish a Welsh-medium school not a Welsh-medium stream
- Additional support would be needed to support the change of language categoy, e.g. working with other Welsh-medium schools and the promotion of Welsh-medium education for non-Welsh speaking parents
- Need to ensure that proficient bilingual teachers and staff are in place at Ysgol y Cribarth
- The School Organisation Code makes it clear that it is necessary to assess the impact of the proposal on the Welsh language. Whilst there is a Welsh language assessment, a more detailed assessment would have been of benefit in strengthening this consultation.

#### vi) Issues raised during the Objection Period

No comments about the proposal's impact on the Welsh language were received during the Objection Period, however some concern was raised about the potential impact on the catchment of Ysgol Gymraeg Dyffryn y Glowyr.

#### vii) Conclusion

Implementation of the proposal would have a positive impact on the Welsh language, as it would build on the successful pilot provision which is currently running at the school, and would ensure that in time, all pupils attending the school would be able to choose Welshmedium education, should they wish, and would become fully bilingual in Welsh and English. This is reflected in comments received during the consultation period.

On a whole school level, the renewed and sustained focus on the Welsh language will broaden the Welsh ethos of Ysgol y Cribarth, leading to an increase in the number of pupils able to use the Welsh language confidently, and contributing to the Welsh Government's Strategy to achieve a million Welsh speakers by 2050.

Many of the respondents to the consultation suggested that the proposal to establish a Welshmedium stream at Ysgol y Cribarth is not ambitious enough, and that the Council should be consulting on changing the school's language category to Welsh-medium. The current proposal reflects the school's current position, and provides an opportunity to develop the Welsh language skills of staff to support the introduction of a Welsh-medium stream. #### 1. Purpose

1.1 The purpose of this report is to present the Draft Welsh Language Standards Annual Report for consideration and approval (see Appendix A). The Report outlines work undertaken during 2022-23 to ensure compliance with the Welsh Language Standards under the Welsh Language (Wales) Measure 2011, and performance against the requirements of the Standards.

#### 2. Background

- 2.1 Under the Welsh Language Standards the Council is required to publish an annual report, outlining the work undertaken to comply with the requirements of the Standards during the previous financial year.
- 2.2 The Draft Welsh Language Standards Annual Report (attached as Appendix A) includes work undertaken to comply with the following Standards:
  - Service Delivery Standards. These state how the Council must deliver services to the public, e.g. by telephone, in meetings, through correspondence, in documents and through digital platforms
  - Policy Making Standards. These state how the Council must consider the impact of its decisions and services on the Welsh language
  - Operational Standards. The information, support and procedures the Council must provide to its workforce to enable them to do more of their work through the medium of Welsh
  - Promotion Standards. These state how the Council intends to promote and increase opportunities to use the Welsh language in Powys.

- 2.3 The report sets out work to be undertaken during 2023-24 to further improve how the Council provides services to its Welsh speaking residents, visitors and workforce. It notes how the Council considers impacts on opportunities to use Welsh and on treating the Welsh language no less favourably than English through its decision-making processes. This includes how the Council could amend proposals to ensure a more positive or less negative impact of policies. The report also notes how the Council promotes the Welsh language and culture through its work.
- 2.4 Sections 4, 5, 6, and 7 include data the Council must record under the Record Keeping Standards of the Welsh Language Measure. These include:
  - Section 4. Complaints received by the Council regarding its compliance with the Welsh Language Standards, along with Welsh Language Standards Investigations conducted by the Welsh Language Commissioner during the 2022-23 financial year
  - Section 5. Data on the Welsh language skills of Council employees
  - Section 6. The number of staff undertaking training courses provided by the Council through the medium of Welsh
  - Section 7. The language skills requirements of new posts and vacancies advertised by the Council during the year.

#### 3. <u>Advice</u>

3.1 To approve the Draft Welsh Language Standards Annual Report 2023 to be published on the Council's public website. This provides a review of work the Council did to ensure compliance with the Welsh Language Standards during the 2022-23 financial year, and to meet its statutory obligations under the Welsh Language (Wales) Measure 2011.

We are in the centre of Wales here in Powys and the Welsh language should be at the centre of how we operate, deliver services and make policy. Welsh belongs to all parts of the county – both in areas where there are a high and a low number of speakers. The Welsh language has a history and a future here.

We are publishing this document in line with Standards 158, 164 and 170 of the Welsh Language Standards. These require us to produce an annual report detailing how we have complied with the service delivery, policy making and operational standards with which we are under a duty to comply.

One of our main achievements was drafting our 5-year Welsh Language Promotion Strategy for 2023-2027. I enjoyed being part of the discussions on how we can help Welsh speakers of all abilities, ages and backgrounds use the language when contacting us and in their communities.

The questionnaire from the Welsh Language Commissioner last autumn helped us examine how we can promote our Welsh services proactively. We want Welsh to be the natural, first choice for those who wish to contact us in the language.

The Census results released in December 2022 were disappointing, showing a 3% decline in speakers in Powys from 19% in 2011 to 16% in 2021. However, we are determined to find practical and innovative ways to halt this decline and promote the use of Welsh. This will be the focus of our 5-year Promotion Strategy.

We need the support of our residents to achieve this. Whether you are a confident Welsh speaker or know only a few words, I encourage you to use the language with us an authority and when you're out and about in the community. Let's make every day a Shwmae / S'mae day.

## 2. Our compliance with the Welsh Language Standards

#### Our arrangements for compliance

We have a full-time Welsh Language Officer who is responsible for complying with and implementing the Welsh Language Standards (the Standards hereafter) and reports to the Welsh Language and Communications Manager.

The Welsh Language Officer (WLO) advises staff and elected members, and monitors compliance across all service areas. The WLO also provides regular updates and guidance to staff by joining team meetings and through internal Corporate Communications.

We are in regular contact with our Liaison Officer from the Welsh Language Commissioner on whom we can call for advice if needed.

The WLO attends regular online meetings of Welsh Language Officers from other authorities which provide opportunities to share best practice and attend presentations on compliance by the Welsh Language Commissioner.

#### Progress against our 2022-2023 Work Plan

Action	Conduct a full review of our processes for receiving and handling telephone calls in Welsh to ensure full compliance with Standards 8-22.

What we did during 2022-2023	A corporate customer service review was still underway at the time of writing this report. The review will address how we handle phone calls in Welsh and is being conducted by BetterGov on our behalf. The Chair of the Welsh Language Governance Panel and the Welsh Language Officer met representatives from BetterGov on 29 March 2023 to discuss our Welsh phone service and areas for improvement. BetterGov is conducting a customer survey that will last until the end of May 2023. The survey asks customers which department they contacted, how, and in which language. It asks customers how they would consider contacting us in future, and whether they have concerns we are treating the Welsh language less favourably than English. The results of the consultation will influence how we deal with Welsh language phone calls from the public. We expect Cabinet to discuss and respond to the survey in autumn 2023.

The Welsh Language Officer is part of the Working Group set up to look at the
customer service review.

The 'customer@powys.gov.uk' email address has been removed so we now have only one customer service email which is: <u>customerservices@powys.gov.uk</u> The <u>customer@powys.gov.uk</u> address was leading to delays in response. We sent guidance to staff through Corporate Communications emails in April 2022 on handling and responding to Welsh emails in accordance with the Standards.
	The guidance reminded staff to use our revised email signature which states how we will handle correspondence in accordance with Standard 7. It also provided guidance on how to respond to a Welsh email using the correct abbreviations, 'Atb:' when replying to an email or 'Yml:' when forwarding an email <sup>1</sup> . It also explained to staff when to send emails to the public bilingually in accordance with Standard 4. <sup>2</sup> The guidance is readily available to staff in the Communications Toolkit on our staff intranet.

# Service Delivery Standards

Below is an outline of further work we did during the 2022-2023 financial year to comply with the Service Delivery Standards.

# Welsh Language Commissioner's Recommendations

An evidence gathering meeting was held with the Welsh Language Commissioner's Liaison Officer on 9 December 2022. The Commissioner reviewed our compliance in autumn and winter 2022 and informed us of areas for improvement. They sent a letter on 25 January 2023 outlining further actions we must take to ensure full compliance with specific standards. We accept the Commissioner's recommendations and have been working to strengthen our processes as a result.

Below we list the issues the Commissioner found and our response.

#### Phone calls we receive

The Commissioner's Liaison Officer (hereafter 'the Commissioner') made three telephone calls in Welsh to our main public switchboard in autumn 2022. Two out of three calls received a full Welsh service. The Commissioner waited for 8 minutes with the third call but did not receive a response before ending the call. The Welsh Language Officer noted that two minutes was our expected standard to answer phone calls regardless of language preference.

#### Our response

Having spoken to the customer service manager, intermittent Wi-Fi signal was found to affect our ability to answer phone calls in accordance with our customer charter (2 minutes). This is more likely to happen when staff are working from home. We've solved the problem and it is no longer causing issues. The Welsh Language Officer conducts mystery shopper calls to our main customer services line regularly and can confirm answer times are quicker, however, when placed on hold, we do not always answer calls within two minutes. We will continue to work to improve our response to Welsh speaking customers and our customer service review will inform this process.

#### Publishing documents on our public website

The Commissioner found 3 out of 3 documents did not contain a statement on the English versions that they were also available in Welsh<sup>4</sup> in accordance with Standard 49.

#### Our response

The Welsh Language Officer has notified the relevant service areas and asked them to amend the documents to include the required wording.

#### Our public website

The Commissioner found that 3 out of 15 pages on our public website were not fully compliant.

#### Our response

We have notified the relevant service areas of this and asked them to amend the relevant pages and documents.

#### Signs we display

In response to the Commissioner's self-assessment questionnaire, we noted medium compliance due to STOP/GO signs on roadworks not being bilingual. The Commissioner agreed that the word STOP is acceptable and is used on the continent.

#### Our response

We asked our highways department to amend the signs and translate GO to EWCH (Welsh for Go). The Senior Highways Operational Manager has confirmed all new signs now display EWCH/GO.

#### **Reception areas**

Covering staff when a receptionist is unwell or on holiday is a problem in ensuring we can offer a Welsh language service.

#### Our response

The Welsh Language Officer has discussed this with the Customer Service Liaison Manager. We still do not have staff to cover should the need arise. Our intention is to resolve this in the coming year.

### Translating and Providing Bilingual Information

The Translation Unit will provide an update (this is not a statutory part of the report).

# Policy Making Standards

- 1. In our 5 Year Strategy for 2023-2027, we noted that our new Local Development Plan will recognise language sensitivity and sustainability as a factor in planning. The Strategy will be approved by Cabinet in July 2023.
- 2. We updated the Impact Assessment template in March 2023 to quote the requirements of the relevant Standards and include links to the Commissioner's Code of Practice and guidance documents.
- 3. The Welsh Language Officer joined impact assessment training for staff which is held every three months and provided guidance on relevant Standards.

# **Operating Standards**

- 1. We established the Welsh Language Governance Panel which has been meeting every three months since the first meeting in September 2022.
- 2. We liaised with Recruitment and Human Resources to prepare to adopt mandatory Welsh Language categorisations we must use when advertising new and vacant posts. Standard 136 of the Welsh Language Standards states that when we assess the needs for a new or vacant role, we must assess the need for skills in Welsh, and categorise it as a position when one or more of the following apply:
  - a. Welsh language skills are essential;
  - b. Welsh language skills need to be learnt when appointed to the post;
  - c. Welsh language skills are desirable; or
  - d. Welsh language skills are not necessary.

We will be adopting these categorisations in June 2023 as requested by the Welsh Language Commissioner.

3. We combined relevant elements from our Welsh Language and Recruitment Policy into our main Recruitment Policy. Having two policies had the potential to cause confusion.

### **Promotion Standards**

We wrote our 5 Year Strategy for 2023-2027 to promote the Welsh language in communities, through our internal operations and through the services we offer. The Strategy was drafted through discussions of the Welsh Language Governance Panel. We will be ready to publish the Strategy by July 2023.

# 4. Complaints

Below we outline the complaints we received relating to the Welsh Language Standards during the 2022-2023 financial year.

#### Welsh Language Commissioner's Investigation: Complaint CS1016

The Welsh Language Commissioner received a complaint from a member of the public on 13 May 2022 about a county councillor's profile on our public website. The complainant mentioned the profile was not available in Welsh. The Commissioner determined that the complaint was valid and began an investigation.

We acknowledged that the complaint was correct on 23 June 2022 and confirmed responsibility. Following an investigation, the Commissioner ruled the following on 19 January 2023:

- 1. Parts of our public website relating to Councillors' profiles were not available in Welsh, and therefore in breach of Standard 52.
- 2. There was no direct link to a Welsh page on the English pages of the Councillor's profile. This was a breach of Standard 55.
- 3. Menus on the information pages relating to Councillor profiles were not available in Welsh. This was a breach of Standard 56.

We gave written evidence to the Commissioner that we had completed the required enforcement actions. This included preparing an action plan setting out how we would address our failures to comply with Standard 52, 55, 56.

The Welsh Language Commissioner approved our action plan on 30 May 2023. This means the action plan comes into force from that day and we have six months to complete it, i.e., by 30 November 2023.

#### Street name sign: Heol y Defaid, Brecon: Complaint CS108

The Welsh Language Commissioner received a complaint on 28 September 2022 relating to the English translation of the name of Heol y Defaid (Ship Street) in the county. The Commissioner decided this was not a matter covered by the Standards. The Commissioner did not conduct an investigation into the complaint as a result.

The Commissioner noted that although Heol y Defaid is the original, correct Welsh name for the street (which means Sheep Street), Ship Street has been a historical adaptation of the name for over two hundred years. This is an example of the word 'sheep' changing to 'ship' in the old English dialect of Brecknockshire.

#### English-only sign in Llansanffraid-ym-Mechain

We received a complaint from a member of the public regarding a temporary English-only sign on the outskirts of Llansanffraid-ym-Mechain. The sign gives instructions about the weight and width of a bridge which is in Llanyblodwel, Shropshire. Shropshire Council placed the sign there in relation to roadworks they are carrying out in Shropshire.

In November 2022 and February 2023 we asked Shropshire Council to place a bilingual sign but this has still not happened at the time of writing. We have asked Shropshire Council's street works department again, providing them with a translation of the necessary text.

### Temporary road signs, Montgomery

We received a complaint from a member of the public on 22 April 2022 regarding English-only temporary signage on Chirbury Road, Montgomery. The signs were put there by contractors.

The complainant also drew our attention to speed limit signs on either side of a railway bridge on the A458 between Buttington and Trewern containing errors in the Welsh. As the A458 is a trunk road, this is the responsibility of the Welsh Government, not Powys County Council. We informed the Welsh Government's highways department on behalf of the complainant.

We received no complaints relating to policy making or operational standards.

### E-learning courses

We provide the following training courses bilingually: Child Protection and Safeguarding; Violence against Women; Cyber Security and GDPR; Domestic Abuse and Sexual Violence; Dementia Awareness training; Manual Handling (people); the Prevent course; and Social Care Wales and NHS Carers Awareness training. These courses are provided by external providers through the NHS and Home Office e-learning portals. Reporting on these courses, including the language in which they were accessed, is not currently available from the provider.

We provide further training digitally through Netconsent, software that requires employees to read policies, complete surveys and complete training before logging on to their PCs. This is provided in Welsh or English automatically, depending on the language selected by each user when they first access Netconsent. User language choice data isn't stored within Netconsent software, and it is therefore not possible to report on the number and percentage of users accessing this training in Welsh.

I can pronounce Welsh personal and place names correctly, and I can give and respond to basic greetings on the telephone or in person.

#### Level 2

I can communicate routine tasks requiring a simple exchange of information on familiar topics and activities. I can handle very short social exchanges, even though I can't usually understand enough to keep the conversation going myself.

#### Level 3

I can deal with most situations likely to arise whilst travelling in an area where the language is spoken. I can enter unprepared into conversation on topics that are familiar or relevant to everyday life (e.g. family, hobbies, work).

### Level 4

I can interact with a degree of fluency and spontaneity that makes interaction with native speakers possible. I can take an active part in discussion in familiar contexts.

### Level 5

I can take part effortlessly in any conversation or discussion and have a good familiarity with idiomatic expressions and colloquialisms. I can express myself fluently and convey finer shades of meaning precisely.

### 1. Purpose

1.1 This report provides an update on the financial position of the Council's capital programme for 2022/23 as at 31<sup>st</sup> March 2023.

### 2. <u>Background</u>

- 2.1 The 2022/23 Capital Programme was approved by Council on the 3<sup>rd</sup> March 2022. It included capital schemes totalling £133.88 million, of which £25.55 million related to the Housing Revenue Account (HRA). The programme has been updated following the reprofiling of projects and additional grants received from Welsh Government.

# 5. <u>Virements</u>

- 5.1 **Small Capital Bids 2023/24 -** The Capital Strategy approved for 2023/24 contains £0.50m funding for small projects from £0.01m to £0.10m. Bids were prioritised using preset criteria and funding was distributed to the following schemes.
  - £85k New lift and medical room at Ladywell House, Newtown.

- £100k Four new highway weather stations in relation to gritting.
- £50k Upgrade pay and display machines to 4G.
- £70k New wall at Knighton Cemetery.
- £60k Replacement filters in leisure centre pools.
- £25k Structural improvements at Lakeside Restaurant and Boathouse, Llandrindod Wells.
- £45k Replace asbestos roofs on county farm buildings.
- £35k New noise meters for Environmental Protection.
- £30k Sewerage works at Brecon Boathouse.
- 5.2 **Community Equipment Store** A business case was presented to the Capital Oversight Board (COB) setting out the case for funding to carry out urgent capital works on the Community Equipment Store in Newtown. This was supported by the COB and cabinet are requested to approve an allocation £0.22 million for these works, it will be funded by from existing capital budgets that are not required at this stage.

# 6. Capital Receipts

6.1 A total of £2.93 million was received in 2022/23 (including £0.39 million for the HRA). There are a further £1.14 million of sales agreed, these are at the legal stage of the process and will generate future capital receipts.

# 7. <u>Resource Implications</u>

7.1 The Head of Finance (Section 151 Officer) notes the content of the report. The reprofiling of schemes is essential to enable us to more accurately project expenditure, the consequential need to borrow and the impact on the revenue budget. Expenditure on the Capital Programme continues to be monitored carefully through the year, the impact of rising costs, supply chain issues and additional borrowing costs will have to be carefully considered. Prioritisation of resources at a corporate level ensures that the council can effectively meet its objectives whilst maintaining an affordable level of investment.

Residential development – works to refurbish and improve a range of properties for childrens residential care have been completed in order to meet Care Inspectorate Wales (CIW) requirements.

Work to meet CIW requirements at the Safe Accommodation residential property have commenced and a small proportion of works will now be completed 23/24. Funding has been secured in 23/24 to complete the work.

The Oldford Family Centre in Welshpool has been completed and was opened by Deputy Minister in March 2023. This is a multi-agency hub providing support to children, young people and their families in the Welshpool area. Scoping for possible funding underway to replicate in the South of the County.

Works on the Flying Start Childcare hub in Brecon is nearing completion and WG agreed for capital funds to be moved to 23/24 to support this.

### Transforming Education Programme

The Council's Transforming Education Programme has continued to make steady progress this year. The latest status of each project is outlined below:

- **Ysgol Gymraeg y Trallwng**, a 150 place Welsh-medium school in Welshpool opened to pupils in May 2023.
- Cedewain Special School, Newtown construction is underway, with the new building expected to open to pupils in the autumn term 2023.
- **Brynllywarch Hall School, Kerry** a contractor was previously appointed for this scheme, which is to construct a new behavioural, emotional and social difficulties (BESD) school for pupils with complex behavioural needs. However, the Council is still awaiting final cost information. This is due to be received from the contractor by the end of June 2023. Once this is received, consideration will need to be given to how to proceed.
- Sennybridge C.P. School the tender package for constructing a new build 150 place school to replace the current poor condition buildings has been published. Tenders are to be submitted by the 7<sup>th</sup> July.
- Ysgol Bro Hyddgen, Machynlleth a decision has been made to reduce the scope of the planned new building. This will no longer include leisure and library facilities. Royal Institute of British Architects (RIBA) stage 2 has now been completed based on the revised scope.
- Ysgol Calon y Dderwen, Newtown work on plans to provide a replacement primary school for Ysgol Calon y Dderwen continued, with the designs progressed to RIBA 2 stage. However, further discussions have taken place regarding the size of the new building, which may result in revising the current designs. This project forms part of the North Powys Well-being Campus development, which is planned for Newtown. Linkages with the North Powys Well-being Programme are a key feature of this project. The Council will continue to work closely with colleagues within Powys teaching Health Board (PtHB) as discussions around changing the scope of the project develop.

Cost uncertainty, market fluctuations and material availability have continued to be issues for the Programme in the last financial year and will continue to need robust management and scrutiny of costs as projects develop this year.

# Major Improvement Programme

The Council's annual capital programme has made very good progress, in this financial year, there are 150 projects with:

- 2 projects on hold
- 10 schemes to commission
- 6 schemes commissioned.

- 17 at the design stage
- 13 at the tender stage
- 14 at the construction stage
- 88 schemes are practically completed on site.

The overall programme budget is  $\pounds$ 5,269,753 for 2022/23 with expenditure of  $\pounds$ 4,712,191 to end of March 2023. There were several project's in this programme part funded by Welsh Government Community Focus & Additional Learning Needs Grants.

The Energy Company Obligation (ECO) 4 / Optimised Retrofit Programme (ORP) 3 Retrofit programme continues, with the completion of works to properties with low E, F, G Energy Performance Certificates (EPC). This programme will continue through 2023-2024 and 2024-2025.

# Housing General Fund

Demand for disabled facilities grants (DFGs) remains high with delivery adversely affected by the challenges experienced in securing contractors to undertake work.

Demand for, and cost of, homelessness related services remains high.

# Economy

Overall capital budgets are managed from grant funds and profiled until March 2025. This process is managed through quarterly reporting fund management and slippage is being managed in monthly review meetings with partners and contractors. This includes:

**Transforming Towns Programme** £5,080,000 for Placemaking Grant is managed through an application process. The capital fund is managed through a local and regional panel and the spend profile for 2022/23 is slightly under target spend but with approval for roll forward to 2023/24 being confirmed.

**Levelling-up Capital Projects**. Project expenditure is currently behind schedule, but this is regularly reviewed with partners to ensure delivery against grant terms and conditions. Council project aspects are being managed carefully and costs are within contingency limits with work slightly behind schedule but within grant agreements. Any required changes will be considered as a one-off Performance Assessment Review (PAR) review during the lifetime of the project.

# **Digital Services Capital**

Again, there has been no significant change since the previous quarters update. The majority of the reprofiled allocation has been spent as planned. Major projects have already been aligned for the following year.
