I drafted and proposed a motion to Council about public participation at Council meetings in order to enhance transparency and public engagement. This was passed by councillors and I hope that it will lead to opportunities for members of the public to address elected members.

- I have delivered Focus newsletters to households, attended Police Community Support Officer [PCSO] surgeries to raise local issues and attended, and fed into, consultations that have affected my ward and its residents, including those on services for older people, dog fouling, transport and rubbish collections.
- I have worked hard to ensure the ward looks and functions as smoothly as possible by monitoring projects taking place, ensuring issues to do with waste, potholes, lighting and drains are reported, litter picking and assisting with schemes to enhance the area.
- I undertook a range of casework on behalf of residents relating to housing, benefits, waste, parking, speeding, local environment, transport, planning and other issues.

- Residents contacted me by phone, email, in person and I spoke to people about their concerns by going around the ward and by knocking on doors.
- I gave evidence at the Newtown Bypass Inquiry on behalf of my residents, supporting the bypass and highlighting the use of my ward by vehicles attempting to circumvent congestion on the A483.
  - I worked with local residents, the local environment team and the Town Council to highlight problems with dog fouling in the ward, tackle problem spots and ensure new bins were put in place.
