### Section 2: Constituency Activity

#### a) Community Councils.

In my Dolforwyn Ward I have two Community Councils, Abermule with Llandyssil Community Council and the Bettws Cedewain Community Councils. I consider it to be vitally important that County Councillors provide a link and support for the Community Councils. I therefore attended most meetings of both Community Councils and assisted them in every way possible and also kept them updated on all relevant issues.

#### b) Community Newsletters.

In my Dolforwyn Ward there are three Community Newsletters, for Abermule, Llandyssil and Bettws Cedewain. I used these newsletters to keep residents informed and updated on all relevant matters appertaining to Powys County Council and also the local community. Due to space constraints this sometimes entailed the printing of 'inserts' to provide extra information space. The

information I provided was greatly valued by the Communities.

**c) Contact with Residents.**

I held surgeries in my Ward, but made it well known that in the case of any problems or complaints, I would undertake visits to see constituents in their own homes or they could call to see me by appointment in my office at home. However, I held Community Meetings for large issues. I organised Community Meetings in early May 2013 for Local Development Plan Consultation, in the villages of Abermule, Bettws and Llandyssil.

**d) Information Website.**

I maintained, at my own expense, a simple website ([cllrwynnejones.co.uk](http://cllrwynnejones.co.uk)) on which I published relevant information about Powys and local issues, listed my responsibilities and also details of my remuneration (including my monthly expenses claims).

**e) Community Centres**

I have three Community Centres in my ward: Abermule, Bettws Cedewain and Llandyssil. These are greatly valued community facilities and act as the hub of each community. I provided as much support as possible for each Community Centre, providing them with help and advice and assistance in applying for grant funding. From time to time I also attended their Management Committee Meetings. In the last year I have assisted all three Community Centres with grant applications that have resulted in improvements to existing facilities.

**Section 3: Learning & Development** - after the Elections in May 2012 induction sessions were provided during May and June to ensure that Councillors could undertake their roles. Ongoing monthly development is provided.

Induction sessions – Code of Conduct; Safeguarding and Corporate Parenting; Planning Protocol; Welsh Local Government Association Scrutiny Induction.

Ongoing Development - Welsh Housing Standards, Alternative Management and Delivery of Leisure Services; Estyn Update; Performance and Project Management; Adult Social Care; Welfare Reform Act.

**Section 4: Outside Organisations and Other Activities**

I was also a Trustee [in my capacity as the Local Member] and Chairman of the Millfields Amenity Land Trust, which is a Local Trust Fund that maintains Community Facilities in the village of Abermule.

I also served on the All Wales Performance Monitoring Committee as a representative of Local Authorities in East Wales Region.

### Adran 2: Gweithgareddau yn yr Etholaeth

#### a) Cyngorau Cymuned.

Yn fy ward, Ward Dolforwyn, mae gennyf ddau Gyngor Cymuned, Chyngor Cymuned Aber-miwl gyda Llandysul a Chyngor Cymuned Betws Cedewain. Rwy'n credu ei bod yn hanfodol i Gynghorwyr Sir fod yn gyswllt ac yn gefn i'r Cyngorau Cymuned. Rwyf felly'n mynychu'r rhan fwyaf o gyfarfodydd y Cyngorau Cymuned ac yn eu cynorthwyo ym mhob ffordd bosib a rhoddais iddynt hefyd yr holl wybodaeth ddiweddaraf am faterion perthnasol.

#### b) Cylchlythyron Cymunedol.

Yn fy ward, Ward Dolforwyn, ceir tri Chylchlythyr Cymunedol, i Aber-miwl, Llandysul a Betws Cedewain. Defnyddiais y cylchlythyron hyn i roi'r newyddion diweddaraf i'r trigolion am y materion perthnasol a oedd yn ymwneud â Chyngor Sir Powys a hefyd am y gymuned leol. Oherwydd prinder lle roedd hyn weithiau'n

golygu argraffu 'mewnosodiadau' i ddarparu gofod ychwanegol ar gyfer gwybodaeth. Roedd y Cymunedau'n gwerthfawrogi'n fawr y wybodaeth a ddarparais.

**c) Cysylltu â'r Trigolion.**

Cynhaliais gymorthfeydd yn fy Ward, ond gan hysbysu'n eang, os oedd gan bobl broblemau neu gwynion, y byddwn yn cynnal ymweliadau i weld yr etholwyr yn eu cartrefi eu hunain neu y gallent alw i'm gweld drwy apwyntiad yn fy swyddfa gartref. Er hynny, cynhaliais Gyfarfodydd Cymunedol ar gyfer materion sylweddol. Trefnais Gyfarfodydd Cymunedol ddechrau Mai 2013 i Ymgynghori ar y Cynllun Datblygu Lleol, ym mhentrefi Aber-miwl, Betws a Llandysul.

**d) Gwefan Wybodaeth.**

Ar fy nghost fy hun, cynhaliais wefan syml ([cllrwynnejones.co.uk](http://cllrwynnejones.co.uk)) lle cyhoeddais wybodaeth berthnasol am Bowys a materion lleol, lle rhestrais fy nghyfrifoldebau a hefyd fanylion fy nghydnabyddiaeth ariannol (gan gynnwys fy hawliadau misol am dreuliau).

**e) Canolfannau Bro**

Mae gennyf dair Canolfan Fro yn fy ward: Aber-miwl, Betws Cedewain a Llandysul. Maent yn gyfleusterau cymunedol gwerthfawr iawn a gweithredant fel y canolbwynt i bob cymuned. Darperais gymaint o gefnogaeth â phosib i bob Canolfan Fro, gan roi iddynt help a chynghor a chymorth i ymgeisio am arian grant. O bryd i'w gilydd, fe wnes i hefyd fynychu Cyfarfodydd eu Pwyllgor Rheoli. Dros y flwyddyn diwethaf rwyf wedi cynorthwyo'r tair Canolfan Fro gyda cheisiadau am grant sydd wedi arwain at wella'r cyfleusterau presennol.
