Section 2: Portfolio Holder for Adult Social Care

Responsibilities include: Mental Health. Older People. Disabled People. Learning Disabilities. Carers Services. Substance Misuse. (Operational services covers both care management and provider services). Commissioning and Contracting. Adult Social Services Policy Interpretation and Development. Domiciliary Care.

I was also part of the Health and Adult Social Care Integrated Leadership Board who have a number of collaborative work streams under way in Mental Health, Older People, Disabled People, Learning Disabilities and Carers Services.

I also sat on the Welsh Local Government Association's [WLGA's] Social Services Policy Group (SSPG), which exists as an advisory arm to the WLGA and is chaired by the WLGA's Political Spokesperson for Health and Social Services. Its membership consists of cabinet members from each local authority in Wales with a responsibility for social services. The SSPG meets on an all Wales level biannually with the Deputy Minister for Children and Social Services. Regional SSPG meetings also take place quarterly in north Wales, mid and west Wales and south east Wales.

Furthermore I represented the authority on the Mid and West Wales Health and Social Care Collaborative Board which has been established with the aim of 'providing a strategic framework for coordinating and delivering a range of health and social care programmes across the region, maximising resources available, reducing duplication, achieving consistency and bringing about service improvement and transformational change in how we jointly commission and procure high quality services at a better price, improving outcomes for citizens in the region'. As such the Collaborative is the key driver within the Mid and West Wales region for the implementation of Sustainable Social Services and local delivery of new requirements placed on Local Government and its partners by the forthcoming Social Services and Wellbeing (Wales) Bill. Partners within the Collaborative are Carmarthenshire County Council, Ceredigion County Council, Pembrokeshire County Council, Powys County Council, Hywel Dda Health Board and Powys Teaching Health Board.
