I served on the Cabinet [actual attendance/number of meetings held] – 19/19

My Portfolio responsibilities included the following:

Local Service Board [LSB] Chair, Change Programme, Business Manager, Organisational development and partnership support (Shared with designated Portfolio holder) and One Powys Plan. I have responsibility to appoint and remove individuals to and from the Cabinet and to allocate Cabinet Portfolios.
