




#### Data Protection Act 1998

Legislation to regulate the processing of personal data, and also provides and protects the rights of the individual.

 In order to improve we must learn from our mistakes.



























































### **Statutory Regulator**

Information Commissioner (ICO)

 Requirement to register the processing of personal data with ICO





# **Statutory Regulator**

Other powers include being able to;

 Impose fines of up to £500,000 for serious breaches of data security

 Issue enforcement orders against organisations to improve practices





### **Statutory Regulator**

- In December 2011 Powys County Council was fined £130,000 for a serious breach of the act where a child's information was sent to the wrong recipient.
- An enforcement order was also made requiring ALL staff with access to personal data to undertake and pass training on the Data Protection Act and our Policies every three years.





#### Learning from others

Greater Manchester Police has been fined £150,000 after three DVDs containing footage of interviews with victims of violent or sexual crimes got lost in the post.

The London Borough of Ealing was required to sign an undertaking to improve their training compliance and develop process for protecting manual information after a Social Worker left care proceedings documents on the roof of their car when leaving Court.

Norfolk County Council left files that included sensitive information about children in a cabinet sent to a second hand shop was fined £60,000

Dyfed-Powys Police was fined £150,000 for sending an email containing details of 8 sex offenders in Powys to a member of the public in error.


