### TOWARDS 2040, POWYS' WELL-BEING PLAN 2018 19<sup>TH</sup> MARCH 2018

#### 1. REPORT PURPOSE

1.1	This report is for the purpose of formally approving Towards 2040, the Powys Public Service Board's (PSB's) Well-being Plan in accordance with its statutory requirements to publish a plan to improve well-being before 3rd May 2018.	
1.2	The Well-being Plan provides clarity on the direction of our public services in the promotion of well-being for residents and communities of Powys.	
	The plan sets out long-term objectives to improve the well-being of residents and communities.	
	Having this long-term plan for Powys will help to ensure that those services delivered individually, and those delivered together are provided in a collaborative and integrated way.	
	Adopting the 'golden thread' shows how all organisations contribute to securing the 'Powys we want in 2040'.	
1.3	The Cabinet's Vision 2025 is closely aligned to the Towards 2040 plan and outcomes.	
1.4	The following members of the PSB will be presenting the final well-being plan to their respective Board, or delegated committee, for approval and adoption.   The feedback received from the statutory consultees and through the engagement.
- 2.5 The feedback received from the statutory consultees and through the engagement have been incorporated into the final plan. A formal response will be sent to the statutory consultees detailing how their comments have been considered.
- 2.6 The final version of Towards 2040, the Powys Well-being Plan, was agreed by Powys PSB on Friday 2<sup>nd</sup> March 2018.

4.3	The published Well-being Plan will be produced bilingually in accordance with Welsh			
	Language standards.

	requested.
