I have dealt with many wide ranging issues for residents who have contacted me. These have included:

- Highways issues including pot holes, poor road surfaces, blocked drains, flooding, road closures, dangerously parked cars, abandoned cars, overhanging hedges, hidden road signs, faulty street lamps, street lamps that are too bright, lack of grass cutting and speed enforcement,

- Planning matters including consultations, advice to applicants and enforcement issues,
- Information about boilers/insulation,
- Broadband,
