### Section 2: Constituency activity

I was involved in ongoing case work concerning housing, social care, education, highway, recycling & planning issues etc. I was in regular contact with Officers to resolve issues within my Ward such as the Welshpool Gyrotory system, highway, gritting and parking issues, ensuring that street lighting problems were resolved and liaising with Officers re housing concerns. I worked hard to continually improve the local environment.

I was contactable by telephone, email & letter. I regularly met with residents to discuss and help resolve local and personal issues.

I attended Police and Community Together [PACT] meetings, Tenant Panel meetings, meetings of the full Welshpool Town Council and whenever possible I attended and took part in local events.
