Section 2: Constituency activity

I worked closely with the four Community Councils in my ward, offering support and information when requested. Individual constituents regularly contacted me seeking advice, information and support on a wide range of issues.

I was involved in various on-going projects within the ward including –

Llanafan Fawr/Llanwrthwl Broadband project – seeking a solution to poor broadband provision in this rural area. Working as one of the project team, we meet weekly online with our chosen provider – Broadway Partners, supported by PCC Community Broadband Officer. The project application is awaiting approval from DCMS.

Online community meetings chaired by myself to share information.

Organising promotion, including erection of banners and media reports.

Meetings with MP and MS to seek support for the project.

Our project was selected as one of 3 pilot projects supported by PCC Regeneration team. I support my neighbouring councillors in developing their own projects.

I have now instigated a second scheme to cover Duhonw and Cilmeri wards. Work includes promotion of the scheme and seeking expressions of interest.

Improvements to Golf Links junction – working with Community Council/local residents in lobbying Welsh Government [WG] (Trunk Road) to seek improvements to this hazardous junction. Ongoing correspondence with former MS - Kirsty Williams and Trunk Road Agency. Site meeting held with newly appointed MS – James Evans.

Working with Cilmeri Community Council to highlight importance of Llewelyn's Monument. Meetings with WG Heritage Minister and Cadw regarding new signage, information boards etc.

New village signs have been erected incorporating reference to Llewelyn.

Worked with Farming Unions, local representatives and PCC staff to ensure reopening of Builth Livestock Market. Organised gathering of farmers to show support.

Continued to work closely with Builth Wells Town Council and Builth Community Support during Covid 19 lockdown. Organising information leaflet drop (supported by Builth Wells YFC) to constituents. Delivering shopping and prescriptions to elderly residents who are isolating.

Rwyf wedi dechrau ail gynllun erbyn hyn i ddarparu ar gyfer wardiau Duhonwy a Chilmeri. Mae gwaith yn cynnwys hyrwyddo'r cynllun a chwilio am fynegiadau o ddiddordeb.

Gwelliant i gyffordd y Golf Links - gweithio gyda'r Cyngor Cymuned/preswylwyr lleol i lobio Llywodraeth Cymru [LIC] (Cefnffordd) i geisio gwelliannau i'r gyffordd beryglus hon. Gohebiaeth barhaus gyda'r cyn AS – Kirsty Williams a'r Asiantaeth Cefn Ffyrdd. Cynhaliwyd cyfarfod safle gyda'r Aelod newydd o'r Senedd a benodwyd yn ddiweddar – James Evans.

Gweithio gyda Chyngor Cymuned Cilmeri i ddwyn sylw at bwysigrwydd Cofeb Llywelyn. Cyfarfod â Gweinidog Treftadaeth LIC a Cadw ynghylch arwyddion, byrddau gwybodaeth ac ati.

Mae arwyddion pentref newydd wedi cael eu codi yn cynnwys cyfeiriad at Lywelyn. Rwyf wedi gweithio gyda'r Undebau Ffermio, cynrychiolwyr lleol a staff CSP i sicrhau ailagor Marchnad Da Byw Llanfair-ym-Muallt. Rwyf wedi trefnu casgliad o ffermwyr i ddangos cefnogaeth..

Rwyf wedi parhau i weithio'n agos gyda Chyngor Tref Llanfair-ym-Muallt a Chymorth Cymuned Llanfair-ym-Muallt yn ystod y cyfnod clo Covid 19.
