### Section 2: Constituency activity

Throughout the year I have been active in supporting residents across the ward on planning matters. Specifically supporting the local community opposition to developments at the end of Cefnlllys Lane and helping residents in Pentrosfa as they worked to ensure planning conditions were enforced on Pentrosfa Leys.

I have lobbied for investment in the road network and am pleased by the recent work on Cefnlllys and news that it will be extended as far as Cefn Morfa later in 2018 along with additional work on Grosvenor Road.

The two key issues for the ward this year has been the significant investment in the Lake area which is now nearing full completion and the impact and community involvement in responding to the severe weather events has been welcoming. I have now commenced work across the ward to develop a volunteer coordination network to respond to future instances.

I have also taken a lead role in establishing community support networks in respect of the Syrian Refugee relocation program, initially on-line, then helping to establish Llandrindod Refugee Support.

Much of the work however has been small tasks like ensuring the fallen fence on the Ridgebourne estate was repaired and many small potholes filled.
