Section 2: Constituency Activity

Within my ward I have undertaken the following:

- A new short road has been adopted by the Council, which was put in after improvements to the new A470, which leads to several properties and means that the owners will no longer have to maintain this short road.
- Improvements to the bends on the A483 by New Mead turn, where there were frequent accidents. The improvements have now stopped the accidents.
- I claimed my travel expenses, which I gave back to my community each year. This includes £800 to the churches and chapels within my ward, also supplying Christmas and lights to Howey Village Hall and Sunny Haven.
- Obtained about a £4500 grant for a bus shelter to be put in Caerwnon Park. I will also be putting in a concrete base at my own expense.
- I was successful in campaigning to get bus services continued to Caerwnon Park after the threat of taking it away to save costs. The service is a five day service.
- Got extra white lines outside Howey Village Hall marking the roadway and had extra white lines put outside Pont-Ithan bridge Newbridge.
- Had several meetings with park owners regarding the new legislation which came in last year.
- Led the Conservative Group on saving ALN schools which proved to be successful

with the help of parents.

- Obtained repairs to roads and to the bus shelter at Howey village.
- Successfully campaigned for the mobile post office to come to Howey village after the permanent post office closed.

O fewn fy ward, rwyf wedi cyflawni'r canlynol:

- Mae ffordd fer newydd wedi cael ei mabwysiadu gan y Cyngor, a luniwyd wedi'r gwelliannau i ffordd newydd yr A470, sy'n arwain at sawl eiddo ac sy'n golygu na fydd rhaid i'r perchnogion gynnal a chadw'r ffordd fer hon bellach.
- Gwelliannau i'r corneli ar ffordd yr A483 ger troad New Mead, lle'r oedd damweiniau rheolaidd. Mae'r gwelliannau wedi rhoi terfyn ar y damweiniau erbyn hyn.
- Fe hawliais fy nghostau teithio, ac rwyf yn rhoi'r arian hwn yn ôl i'm cymuned bob blwyddyn. Mae hyn yn cynnwys £800 i'r eglwysi a'r capeli o fewn fy ward, gan gyflenwi goleuadau Nadolig i Neuadd Bentref Hawy a Sunny Haven hefyd.
- Cafodd grant o £4500 ei sicrhau i godi cysgodfan bws ym Mharc Caerwnon. Byddaf yn talu fy hunan i osod sylfaen concrit ar gyfer hyn.
- Roeddwn yn llwyddiannus wrth ymgyrchu i sicrhau fod gwasanaethau bws yn parhau i Barc Caerwnon wedi'r bygythiad o'u tynnu'n ôl i arbed costau. Gwasanaeth pum diwrnod yw'r gwasanaeth hwn.
- Fe lwyddais i sicrhau fod llinellau gwyn ychwanegol yn cael eu gosod y tu allan i

- Rwyf wedi arwain y Grŵp Ceidwadwyr ar achub ysgolion Anghenion Dysgu Ychwanegol a brofodd i fod yn llwyddiannus gyda help rhieni.
- Rwyf wedi sicrhau atgyweiriadau ar ffyrdd a'r gysgodfan bws ym mhentref Hawy.
