Section 2: Constituency Activity

I list below some of the issues I have dealt with on behalf of constituents and for the Ward:-

- Obtained a seat for the bus shelter outside Sunnyhaven Park.
- Worked with residents of Caerwnon Park regarding changes to bus timetables. A petition was received by Councillor Barry Thomas, Cabinet Member responsible for Highways. There has been some success with arrangements made for bus transport to the Doctor's Surgery in Builth Wells in time for surgery. I have asked that the Llandrindod Wells bus service changes to allow residents to carry out their shopping. Thanks to those residents who raised their concerns and for taking the time to come to County Hall.
- Last Summer I met with park home residents together with Andrew Davies, AM, to talk about park homes tax banding. I have written to Kirsty Williams AM and Carl Sargeant AM and await their responses.
- I noted the lack of salting at Sunnyhaven Park and arranged for lorries to attend from the Council to salt this area free of charge. Hopefully, when new legislation for park home owners comes into force this year, park homes will also require site licences from Councils which will enable issues such as this to be dealt with, ensuring the safety of residents.
- I worked towards obtaining parking restrictions on the A483 over Dolberthog Bridge. I met with Kirsty Williams, AM on site and she agreed to contact the

Minister and a response is awaited in this respect. I also contacted the Council for double yellow lines to be drawn because vehicles have been parking on the slip road before the entrance to the bridge, causing access problems.

- I made arrangements with Powys County Council to clear the snow from the roads and pavements in Howey and surrounding areas and to fill salt bins along the way. I believe the workforce did a good job;
- I instigated the placing of two dog litter bins, one near the junction to Hundred House Road and another near Llwynbrain Villas. I have received a request for one in Cwmbach and this is being considered;
- I have dealt with several complaints about blocked drains and potholes and these have been attended to and other matters such as collapsed walls.
- The main A483 by Pencerrig Hotel has been the site of several accidents and I have asked for the road surface to be improved in this area. The work will take place during the Summer of 2013.
- I supported the move for free parking during December 2012;
- I helped arrange Post Office Outreach Services in Howey following closure of the local Post Office facilities;
- I think that all retrospective planning applications should attract increased fees. I am informed that these fees are determined by the Assembly so I have written to Andrew Davies A.M. about this.
- I donated Christmas trees to Sunnyhaven Park and to Caerwnon Park in 2012;
- I pledged the expenses I claim between home and County Hall to the Community of Disserseth and Trecoed each year.
- Finally, I continue to work with the Community Council to make a difference
- My responsibilities are to the residents of Disserseth and Trecoed and I work to put them before anything else.

Section 3: Learning & Development - after the elections in May 2012 induction sessions were provided during May and June to ensure that Councillors could undertake their roles. Ongoing monthly development is provided.

Induction Sessions – Induction 1,2 & 3; Code of Conduct; Regulatory Committee – Planning, Windfarms, Rights of Way, Taxi Licensing; Safeguarding and Corporate Parenting; Planning Protocol.

Ongoing Development - Treasury Management; Information Handling and Data Protection, Welsh Housing Standards, Performance and Project Management; Adult Social Care; Members' Annual Reports and using Outlook.

Rhestraf isod rai o'r materion yr wyf wedi ymdrin â hwy ar ran etholwyr a'r Ward:-

- Llwyddais i sicrhau sedd ar gyfer y lloches bws y tu allan i Barc Sunnyhaven.
- Gweithiais gyda thrigolion Parc Caerwnon ynghylch newidiadau i amserlenni bysiau. Derbyniwyd deiseb gan y Cynghorydd Barry Thomas, Aelod Cabinet sy'n gyfrifol am Briffyrd. Cafwyd rhywfaint o lwyddiant gyda threfniadau a wnaed ar gyfer cludiant bws i'r Feddygfa yn Llanfair-ym-Muallt mewn pryd ar gyfer llawdriniaeth. Rwyf wedi gofyn bod amseroedd gwasanaeth bws Llandrindod yn newid i roi cyfle i drigolion wneud eu siopa. Diolch i'r trigolion hynny a fynegodd eu pryderon ac am gymryd yr amser i ddod i Neuadd y Sir.
- Yr haf diwethaf, cyfarfûm â thrigolion Park Home gydag Andrew Davies, AC, i siarad am fand treth Park Home. Rwyf wedi ysgrifennu at Kirsty Williams AC a Carl Sargeant AC ac rwy'n disgwyl eu hymatebion.
- Nodais y diffyg graeanu yn Sunnyhaven Park a threfnais i lorïau'r Cyngor fynd yno i chwalu halen am ddim. Pan ddaw deddfwriaeth newydd ar gyfer perchnogion Park Home i rym eleni, bydd gofyn i Park Home gael trwyddedau safle gan y Cyngor a fydd yn ei gwneud yn bosibl i faterion gael eu trin, gan sicrhau diogelwch y preswylwyr.
- Bûm yn gweithio i sicrhau cyfyngiadau parcio ar yr A483 dros Bont Dolberthog. Cefais gyfarfod â Kirsty Williams, AC ar y safle a chytunodd hi i gysylltu â'r

Gweinidog a disgwylir ymateb. Cysylltais hefyd â'r Cyngor i ofyn am osod llinellau melyn dwbl oherwydd bod cerbydau wedi cael eu parcio ar y ffordd ymadael cyn y fynedfa at y bont, gan achosi problemau mynediad.

- Gwnes drefniadau gyda Chyngor Sir Powys i glirio'r eira oddi ar y ffyrdd a'r palmentydd yn Hawy a'r ardaloedd cyfagos ac i lenwi biniau halen ar hyd y ffordd. Rwy'n credu bod y gweithlu wedi gwneud gwaith da.
- Trefnais i ddau fin sbwriel cŵn gael eu gosod, un ger y gyffordd i Hundred House Road a'r llall ger Llwynbrain Villas. Rwyf wedi derbyn cais am un yng Nghwmbach, ac mae hyn yn cael ei ystyried;
- Rwyf wedi delio â nifer o gwynion am ddraeniau wedi'u blocio a thyllau yn y ffyrdd ac mae'r rhain wedi derbyn sylw ynghyd â materion eraill megis waliau wedi dymchwel.
- Gwelwyd nifer o ddamweiniau ar ffordd yr A483 ger Gwesty Pencerrig ac rwyf wedi gofyn am wella wyneb y ffordd yn yr ardal hon. Bydd y gwaith yn cael ei wneud yn ystod Haf 2013.
- Cefnogais y galw am barcio am ddim yn ystod mis Rhagfyr 2012.
- Helpais i drefnu Gwasanaethau Allgymorth y Swyddfa Bost yn Hawy yn dilyn cau cyfleusterau'r Swyddfa Bost leol;
- Rwy'n credu y dylai pob cais cynllunio ôl-weithredol ddenu ffioedd uwch. Rwy'n gwybod bod y ffioedd hyn yn cael eu pennu gan y Cynulliad felly rwyf wedi ysgrifennu at Andrew Davies AC am hyn.
- Rhoddais goed Nadolig i Barc Sunnyhaven ac i Barc Caerwnon yn 2012.
- Rwy'n cyflwyno'r treuliau rwy'n eu hawlio rhwng fy nghartref a Neuadd y Sir i Gymuned Diserth a Thre-coed bob blwyddyn.
- Yn olaf, rwy'n parhau i weithio gyda'r Cyngor Cymuned i wneud gwahaniaeth
