As a school governor of two schools, I attended meetings and followed up matters raised at meetings with county or community council as necessary. I began work on behalf of Leighton School in putting together a submission to try and achieve Governing Body Bronze Award status for the school.

The Welshpool schools transformation process, into which Leighton School has been included, has meant supporting the Governing body, the school and the community in every way I can, to hopefully retain Leighton School site for future generations of Leighton and surrounding area children.

The County Council's initiative on town and community councils collaborating and working together to make savings has meant, as Chair of the community council, attending a

number of meetings in Montgomery, along with representatives of many surrounding community councils, to form the Vale of Montgomery Rural Cluster.
