Section 2: Constituency activity

The town still had a high percentage of council-housing in its portfolio and, from time to time, issues naturally arose. The initial reaction to recycling proved an issue to some but, thanks to the good-offices of all concerned, any misunderstandings were resolved; as were those of a housing nature.

I attended meetings involving the town council, local businesses and companies and county council officers that were called to take positive action regarding the current financial climate.

I helped individuals to progress housing adaptations, to have a more appropriate refuse and or recycling collection point and or container(s) and with the filling of various forms, etc.

Section 3: Learning & Development - after the elections in May 2012 induction sessions were provided during May and June to ensure that Councillors could undertake their roles. Ongoing monthly development is provided.

Induction sessions – Code of Conduct; Regulatory Committee – Planning, Windfarms, Rights of Way, Taxi Licensing; Licensing Act 2003 and Gambling Act; Safeguarding and Corporate Parenting; Welsh Local Government Association Scrutiny induction.
