Section 2: Constituency activity

It has been a very difficult year for everyone this year given the Covid pandemic but we as County Councillors have been able to continue our duties via various means over the air waves. There have been in my view, many positives to be taken from the experience not least the reduction in amount of travel, time and associated costs it entails. Although I have not been able to undertake any visits I am confident that I have been able to deal with questions and queries via email or over the telephone. I continue to have a very good working relationship with the Community Council and have largely been able to attend their meetings in whatever form.

The village of Kerry is expanding at the moment with the development of the 62 houses on the Dolfororgan View site, there are now 30 houses occupied, I am advised that the remainder are selling well. The development has meant we have been able to install a second pedestrian crossing in the village together with various traffic calming measures, although I am well aware that speeding does remain an issue as it does in many areas in Powys.

I continue in my role as LEA governor at St Micheal's Church in Wales school where I continue to offer help and guidance. I also continue in my role as LEA governor at Brynllwarch Hall as Chairman of Governors, we are at last well on the way to having a new school, hopefully plans should be submitted in the fairly near future. This is long overdue as the staff have had to work in difficult circumstances for many years but at least there is light at the end of the tunnel.

The village of Sarn have recently had local needs housing completed which has been long overdue. There is a further development of 42 houses planned, which I believe are on the point of sale to be s developed.

The village of Dolfor is unfortunately being moved to the Llandinam ward at the next election due to Welsh Government reorganisation despite our representations which were made during the consultation process. It will be very sad not to have them as part of Kerry Community Council as we have all worked extremely well since 1999 during my time as their County Councillor. Each village has supported each other very effectively. It has been my privilege to serve the 3 villages I hope I may be able to do so in the future.
