Governance and Audit Committee Independent Member Lynne Hamilton	Considers matters relating to the strategic financial management of the Council, including approving the statement of accounts, internal audit and Welsh Audit Office reports, risk management and internal control and considers matters relating to the Council's performance self assessment report.
Democratic Services Committee County Councillor Elwyn Vaughan	Considers the staff and resources concerning the democratic services functions and review the adequacy of provision by the authority of staff, accommodation and other resources to discharge the democratic services functions.
Employment and Appeals Committee County Councillor Lucy Roberts	Responsible for short listing the Head of Paid Service, Corporate Directors, and the short listing and appointment of Directors and Heads of Service. The Committee is also responsible for hearing and determining all types of appeals, relating to staffing and where there is a requirement for the involvement of Members and where statute does not provide for a different bespoke type of arrangement.
Health and Care Scrutiny Committee County Councillor Amanda Jenner	Considers matters relating to Adult Social Care, Children's Services, relevant Transformation projects and partnerships
Pensions and Investment Committee County Councillor Peter Lewis	Considers all functions relating to local government pensions.
Learning and Skills Scrutiny Committee County Councillor Gwynfor Thomas	Considers matters such as Education relevant Transformation projects and partnerships.
Economy, Residents, Community and Governance Scrutiny Committee County Councillor Angela Davies	Considers matters such as Central Services, Property, Planning and Public protection, Highways, Transport and Recycling, Housing and Community Development, relevant Transformation projects and partnerships.
