Section 2: Constituency activity

Advice Surgery Sessions: For the last 12 months fortnightly face to face Advice Surgeries have been replaced by scheduled phone-in sessions on a fortnightly basis due to Covid 19.

Annual Report: Produced, published, printed and delivered 1st annual report (October 2020) to all households, updating residents on constituency activities.

Blog: I have a Councillor Jake Berriman Llandrindod North Facebook page and in addition to regular posts and interactions, I continue to post monthly Blogs on my site. These cover a variety of topics as well as providing information on my whereabouts and activities each month, including my Abbeycwmhir weekly walking group.

Local concerns: I maintain a log of all the issues which I am approached to represent people on, including housing matters, rail services, unsightly land, trees and invasive weeds, school transport, business support and recovery, planning, speeding and of course potholes.

Championing local issues: I have played an active role in **litter picking**, engaging both Tsgol Trefonnen and Ysgol Calon Cwmru in community litter picking events, and am in discussion with residents and Keep Wales Tidy over establishing a Town Tidy group. I have been carrying out minor pruning and **environmental improvements** across the North ward, whilst enlisting the support of the Highways team to prune trees, clear gullies

and verges, and chop back vegetation that is impeding the proper use of footpaths and install handrails. I have also been championing wider issues like the frequency of rail services, emergency healthcare, dentistry and the loss of valuable facilities like the driving-test centre and Barclays bank.

I remain in active dialogue with the Welsh Government over speed reduction and a **safe crossing** point on the Tremont Road (by the Tremont Park pedestrian exit), and with the Safer Routes team about a new crossing point between Tesco and Waterloo Road. I am also actively engaging residents and local policing team to establish a speed watch group.

I am working with and on behalf of two groups of residents and other agencies including Powys Council to bring back into use **land for community recreational purposes** at LonCwm Green and Tremont Park Green.

Local to Llandrindod was established by myself and the Llandrindod Wells Town Council Mayor last summer to directly support our town and promote community cohesion, well-being and self confidence. The Town Raffle, which concluded in May 2021, raised £5,350 directly benefiting local shops and businesses. The Childrens' Poetry Competition was so successful it is coming back this year as part of the town's summer activities programme and the 500 word short story competition culminated in a published book which has itself raised further money for good causes in the town.

Community Fund: I have established the Llandrindod North Ward Community Grant Fund, allocating about 5% of my allowance, to local groups benefiting people in my ward. Two awards of £100 were made in the year to support the work of Helping Our Homeless Wales and Ashfield Community Enterprise to support their efforts which directly benefited residents of Llandrindod North Ward during the Covid 19 lockdown period.

Sesiynau Cymorthfeydd Rhoi Cyngor: Am y 12 mis diwethaf, mae Cymorthfeydd Rhoi Cyngor wyneb yn wyneb pob pythefnos wedi cael eu disodli gan sesiynau a drefnir yn ôl amserlen dros y ffôn pob pythefnos oherwydd Covid-19.

Adroddiad Blynnyddol: Rwyf wedi llunio, cyhoeddi, argraffu a chyflwyno fy adroddiad blynnyddol cyntaf (Hydref 2020) i bob aelwyd, yn diweddu trigolion ar weithgareddau'r etholaeth.

Blog: Mae gennyf dudalen Facebook - Y Cyngħoryedd Jake Berriman Gogledd Llandrindod, ac yn ychwanegol at fy mhostiadau a ryngweithiadau rheolaidd, rwyf yn parhau i bostio blogiau misol ar fy safle. Mae'r rhain yn trafod amrywiaeth o bynciau yn ogystal â dangos lle'r wyf wedi bod a'r hyn bues i'n ei wneud bob mis, gan gynnwys fy ngrŵp cerdded wythnosol yn Abaty cwm-hir.

Pryderon Lleol: Rwy'n cadw cofnod o'r holl faterion y mae pobl yn gofyn i mi eu cynrychioli. Mae'r rhain yn cynnwys materion tai, gwasanaethau rheilffordd, tir bler, coed a

chwyn ymledol, cludiant ysgol, cefnogaeth ac adferiad busnesau, cynllunio, goryru ac wrth gwrs, tyllau yn y ffordd ac ati.

Hyrwyddo materion lleol: Rwyf wedi mynd ati'n weithgar i **godi sbwriel**, ymgysylltu gydag Ysgol Trefonnen ac Ysgol Calon Cymru wrth wneud digwyddiadau codi sbwriel cymunedol, ac rwyf mewn trafodaeth gyda thrigolion a Chadw Cymru'n Daclus dros sefydlu grŵp Tref Daclus. Rwyf wedi bod yn cynnal mân waith tocio a **gwelliannau amgylcheddol** ar draws ward y Gogledd, tra'n sicrhau cefnogaeth y tîm Priffyrdd i docio coed, glanhau ffosydd ac ymylon ffyrdd, a thocio planhigion sy'n tyfu ar draws llwybrau ac yn eu gwneud yn anodd mynd atynt i'w defnyddio'n gywir, gan osod rheiliau llaw. Rwyf hefyd wedi bod yn eirioli dros faterion ehangach megis pa rheolaidd yw'r gwasanaethau rheilffyrdd, materion gofal iechyd a deintyddiaeth sy'n dod i'r amlwg a cholli cyfleusterau gwerthfawr megis y ganolfan brofi trwy ffenestr car a banc Barclays.

Rwy'n parhau i gyfathrebu'n gyson â Llywodraeth Cymru ynghylch lleihau'r terfyn cyflymder a chreu **man croesi diogel** ar Heol Tremont (wrth fynedfa cerddwyr Parc Tremont). Rwyf hefyd mewn cyswllt â'r Tîm Llwybrau Diogel mewn perthynas â gosod croesfan newydd rhwng Tesco a Ffordd Waterloo. Bûm yn ymgysylltu'n weithgar gyda thrigolion a'r tîm heddlu lleol i sefydlu grŵp gwyliau cyflymder.

Y Gronfa Gymunedol: Rwyf wedi sefydlu Cronfa Grantiau Cymunedol Ward Gogledd Llandrindod, lle rwy'n dyrannu pump y cant o'm lwfans i grwpiau lleol sy'n gwneud lles i bobl y ward.

Dyfarnwyd dwy wobr o £100 yn y flwyddyn i gefnogi gwaith Helpu'r Digartref Cymru a Menter Gymunedol Ashfield i gefnogi eu hymdrehchion sydd wedi bod o fudd uniongyrchol i drigolion Gogledd Llandrindod yn ystod cyfnod clo Covid 19.
